# RESOLUTION OF THE PASSAIC COUNTY IMPROVEMENT AUTHORITY AWARDING CONTRACT IN CONNECTION WITH THE AUTHORITY'S CAPITAL EQUIPMENT LEASE PROGRAM

- **WHEREAS,** a regular meeting of the Passaic County Improvement Authority (the "Authority") was held on December 12, 2018;
- **WHEREAS,** the Authority has applied to the Local Finance Board for approval of a Capital Equipment Lease Program;
- WHERAS, the award of this contract is subject to Local Finance Board approval of the Authority's Capital Equipment Lease Program;
- **WHEREAS,** the Authority has determined that it is necessary, convenient, and desirable to contract for the services of a Master Lessor to administer its Capital Equipment Lease Program;
- **WHEREAS,** N.J.S.A. 40:37A-55 permits the Authority to enter into such agreement for professional services, subject to the requirements of the Local Public Contracts Law;
- WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids and the agreement itself must be available for public inspection;
- **WHEREAS**, the New Jersey Election Law, specifically N.J.S.A. 19:44A-20.4, permits, but does not require, a contract with an anticipated value in excess of \$17,500, to be awarded through a "fair and open" process;
- WHEREAS, the Authority has advertised the contract for a Master Lessor on the website of the Authority in sufficient time to give notice in advance of the contract;
- WHEREAS, the contract for a Master Lessor is being awarded under a process that provides for public solicitation of qualifications and awarded and disclosed under criteria established in writing by the Authority prior to the solicitation of qualifications;
- **WHEREAS**, the Authority has publicly opened the responses to the published request for proposals and is publicly awarding the contract for Master Lessor;
- **WHEREAS**, the Authority has determined that the process it has used to award the contract for a Master Lessor is a "fair and open" process, pursuant to N.J.S.A. 19:44A-20.7; and

WHEREAS, the Authority desires to appoint <u>U.S. Bancorp Government Leasing</u> and Finance, Inc. as Master Lessor for its Capital Equipment Lease Program.

NOW, THEREFORE, BE IT RESOLVED by the Passaic County Improvement Authority as follows:

- 1. The Authority appoints <u>U.S. Bancorp Government Leasing and Finance</u>, <u>Inc.</u> as Master Lessor of its Capital Equipment Lease Program from January 1, 2019 through December 31, 2020, with possible extensions, and hereby authorizes the Chairman to negotiate and execute an appropriate professional services agreement substantially in the form of the agreement attached hereto.
- 2. This contract is awarded without competitive bidding as a "Professional Service" in accordance with N.J.S.A. 40A:11-5(1)(a) of the Local Public Contracts Law because the contract is for a service performed by a person(s) authorized by law to practice a recognized profession that is regulated by law.
- 3. The Authority has determined that the process it has used to award the contract for a Master Lessor is a "fair and open" process, pursuant to N.J.S.A. 19:44A-20.7
- 4. A notice of the award of this contract shall be printed once in the Official Newspaper of the Authority to satisfy the requirement of the publication of legal notices and a copy of the contract shall be made available for public inspection.
