RESOLUTION OF THE

PASSAIC COUNTY IMPROVEMENT AUTHORITY ESTABLISHING RATES FOR REIMBURSEMENT OF TRAVEL AND FOR REIMBURSEMENT OF CELLULAR TELEPHONE AND DATA SERVICES

WHEREAS, a regular meeting of the Passaic County Improvement Authority (the "Authority") was held on April 28, 2021;

WHEREAS, the Authority desires to set the rates for reimbursement of travel in accordance with the rates for reimbursement of travel set by the United States General Services Administration; and
