RESOLUTION OF THE PASSAIC COUNTY IMPROVEMENT AUTHORITY AMENDING CERTAIN TERMS OF THE ORIGINAL BOND RESOLUTION ADOPTED IN CONNECTION WITH THE \$10,292,000 ORIGINAL AGGREGATE PRINCIPAL AMOUNT OF COUNTY OF PASSAIC GUARANTEED LOAN PROGRAM BONDS (RECOVERY ZONE PROJECTS), SERIES 2010 (FEDERALLY TAXABLE – ISSUER SUBSIDY – RECOVERY ZONE ECONOMIC DEVELOPMENT BONDS)

WHEREAS, on July 28, 2010 the Passaic County Improvement Authority (the "Authority") issued its \$10,292,000 original aggregate principal amount of County of Passaic Guaranteed Loan Program Bonds (Recovery Zone Projects), Series 2010 (Federally Taxable – Issuer Subsidy – Recovery Zone Economic Development Bonds) pursuant to that certain resolution No. 10-040 entitled "RESOLUTION AUTHORIZING THE ISSUANCE OF COUNTY OF PASSAIC GUARANTEED POOLED LOAN PROGRAM BONDS, SERIES 2010 (COUNTY RECOVERY ZONE PROJECTS)", which was duly adopted by the Authority on May 25, 2010, as amended and supplemented in accordance with Section 2.02(1)(e) thereof (collectively the "Original Bond Resolution"; capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Original Bond Resolution); and

WHEREAS, TD Bank National Association (the "Trustee") has requested an amendment to the Original Bond Resolution to conform the denominations required by Sections 2.02(b)(v), 2.03(3), 3.01(2) and 4.04(1) thereof to the sinking fund payment schedule set forth in the Original Bond Resolution (the "2021 Amendment"); and

WHEREAS, pursuant to Section 11.02(a) of the Original Bond Resolution, the Original Bond Resolution may be amended with the consent of the Trustee to cure any ambiguity, supply any omission or cure or correct and defect or inconsistent provision on the Original Bond Resolution; and

WHEREAS, as the Authority and the Trustee agree the 2021 Amendment is necessary and required, the Authority desires to amend the Original Bond Resolution to allow for the 2021 Amendment and authorize the execution of a consent memorializing same (the "2021 Amendment Consent").

NOW THEREFORE BE IT RESOLVED BY THE MEMBERS OF THE PASSAIC COUNTY IMPROVEMENT AUTHORITY, AS FOLLOWS:

Section 1. The first sentence of Section 2.03(3) shall be amended as follows:

"The Series 2010 Bonds shall be issued in denominations of \$5,000 or any integral multiple of \$1,000 in excess of \$5,000."

All other provisions of Section 2.03(3) shall remain unchanged.

All references to denominations in the Original Bond Resolution including Sections 2.02(b)(v), 2.03(3), 3.01(2) and 4.04(1) thereof shall hereby be amended to read "denominations of \$5,000 or any integral multiple of \$1,000 in excess of \$5,000".

- **Section. 2.** Approval of 2021 Amendment Consent. The Executive Director (the "Authorized Officer") is hereby authorized to execute and deliver a 2021 Amendment Consent on behalf of the Authority in such form and with such changes therein as counsel may advise and the officers executing the same may approve, such approval to be evidenced by their execution thereof.
- **Section 2. Consent**. The Authority shall take any and all such actions required by this resolution in order to obtain the consent of the Trustee in order to effectuate the 2021 Amendment contemplated by this resolution.
- Section 3. Incidental Action. The Authorized Office is hereby authorized to execute and deliver such other papers, instruments, certificates, opinions, affidavits and documents, and to take such other action as may be necessary or appropriate in order to carry out the purpose of this resolution, including effectuating the 2021 Amendment Consent, all in accordance with this resolution the foregoing sections hereof.
- **Section 4. Prior Resolutions.** All prior resolutions of the Authority or portions thereof inconsistent herewith are hereby repealed.
- **Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
