### **Reports:**

Monitoring Committee, McFarlane reported that the monitoring committee is set to meet on Friday, May 21, 2021 @ 2:00 PM to review all the monitoring that were completed so far. Butterfield stated that the YSC still needs people to join and volunteer to be part of the monitoring committee.

Allocations Committee, Starr reported that the Allocations Sub-Committee met on May 12, 2021 to discuss the modification and all the items that were going to be reviewed and voted on today. During each meeting they speak about unallocated funds and with the approval done today, they went from having \$95,000 to \$9,415 and thanked the committee for a great job.

Planning Committee, Starr reported on McCombs behalf and stated that the committee met on May 11<sup>th</sup> and identified a few gaps areas in our vision: prevention, social and emotional, athletic league, transportation, ACE's training for providers. The next Planning Sub-Committee meeting will be held on June 8, 2021 @1:00 PM.

Education, Training, and Advocacy Committee, Bogert reported that the committee met on May 5, 2021 and met as a sub-committee last Friday, May 14, 2021 and spoke about their upcoming event that they are planning with the Youth Discussion Panel discussing several topics. They will start with social justice and are working with The Institute of Social Justice through Lanisha Ridley and are looking to have this event on June 30, 2021.

Youth Services Commission Administrators, Starr stated that he wanted to thank all the sub-committee chairs since they have been extremely active. Starr also wanted the committee to look at 3 hyperlinks in the chat with great information and resources for all Passaic County residents:

Starr also reported that they are in receipt of their 2021 Executed Comprehensive Award from JJC and all providers should have received their 2021 Executed Contracts. Starr further thanked and stated that all providers to please continue sending in their monthly reports, expenditures, and complete their JAMS narratives on time. In addition to make sure all clients are entered into JAMS as each program providers monitoring date approaches and are accurate. Starr also stated that their Youth Services Conference is currently in the process of planning and have identified 2 dates, December 2nd, and 3rd, 2021. They are currently working on that agenda and are looking at a hybrid options due to not knowing the capacity of Passaic County Community College in Wanaque. On June 3<sup>rd</sup> along with Jason Harding and Lt. James Lane they will be providing a presentation to Up in PC regarding the new Juvenile Justice Reform Bill.

Timeline of events for YSC Innovations and Comprehensive Plans:

May 31, 2021: Letter of Intent for Innovations is due

June 25, 2021: Eligibility Notice for Innovations will be available

August 6, 2021: Innovations Application must be submitted to the state

September 7, 2021: Comprehensive Plan Update and Monitoring Reports done and submitted to the state

Starr reported that the Restorative Justice Bill 84663 calls for 4 cities to run Restorative Justice Pilot Programs and Paterson, Newark, Trenton, and Camden. Paterson will possibly receive 1.5 million dollars that will going through the Youth Services Commission through a competitive RFP process. Starr proposed that the Youth Services Commission establishes a Restorative Justice Sub-Committee in preparation of receiving those funds that will be utilized for 2022 and 2023. JJC (Juvenile Justice Commission) Compton-Dover reported that the Restorative Justice Grant will go into vote on August 20, 2021 and was 1<sup>st</sup> drafted in September 2020 and is pretty sure that it will pass due to all the planning and revisions being done the last 9 months. JJC (Juvenile Justice Commission) is working on the bill's regulations. Compton-Dover also stated that Kyle Sheehan will no longer be with Passaic County and will now have Bergen, Morris, and Sussex due to some folks retiring. Compton-Dover will remain completely in Passaic County and, Kyle Sheehan will only step in as Compton-Dover's coverage.

Juvenile Detention Alternatives Initiative, Nowling reported that they are in the midst of getting together the 2022 Innovations Proposal and will request the exceptional funding and they will continue with their currently funded programs: PEEP (Passaic Education Enrichment Program), their POP (Probation Orientation Program) and Girls Group. There are currently 4 youth in the PEEP program but are anticipating getting many more youth next year.

Executive Committee, Butterfield stated that the committee discussed all the items on today's agenda.

#### Announcements:

Vince had some announcements about some exciting things happening in Passaic County Department of Human Services. The Rent Relief Program has gone live as of Monday and they received 15 million dollars for rental relief and received another 21 million dollars more added onto it. These dollars are for Covid Related Rental Relief Program to prevent an eviction and to keep people stable in their housing and are carving out funding to help with other services and needs.
