The FY 2021 Annual Plan covers program period from September 1, 2021 to August 31, 2022.

The County expects to receive \$891,398 for the program year that runs from September 1, 2021 to August 31, 2022. Activities in eight communities will provide infrastructure and public facility improvements and two non-profit agencies will provide public services are included in the FY 2021 Action Plan. All activities proposed will serve low and moderate income populations.

Passaic County intends to submit the Annual Action Plan for FY 2021 to the U.S. Department of Housing and Urban Development (HUD) on or about July 15, 2021. The Passaic County Board of County Commissioners is expected to take action on the FY 2021 Annual Action Plan on June 22, 2021.
