Update, April 11, 2021

Please Note: This Update is posted on the Passaic County website, the Passaic County Facebook page, distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers and Therapeutic Recreation staff distribute the Update to residents who wish to receive it.

Since the last Update on April 8, 2021, one nurse who worked on resident unit 2-400/observation unit tested positive on April 10, 2021 during an off-site test. The last date the nurse worked at Preakness was on April 7, 2021. Since the residents on this unit are already on transmission-based precautions, there will not be an additional quarantine. We currently have six staff who are positive out of work. (Note: correction to previous Update --- staff were tested on April 5 and 7, 2021, not April 6 and 8, 2021 as I incorrectly wrote.)

We have received all results from resident testing last week except one. All results received were negative. Currently, we do not have any residents who are positive for COVID-19.

We are saddened to learn that our colleague, Karen Davis, retired Food Services Worker recently passed away. Prior to the Pandemic closures and her retirement, many residents and families had the opportunity to interact with Ms. Davis as she cheerfully worked at the Rotunda Café each afternoon. We offer our heartfelt condolences to Ms. Davis' family which includes one of our Food Services Workers.

Weather-permitting, staff and residents are planning to have a Baseball Opening Day/DJ Dance Party in the resident patio, socially-distanced, on April 13, 2021. Staff and residents are encouraged to wear their favorite baseball team shirt.
