Update, August 13, 2021

Please Note: This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers and Therapeutic Recreation staff distribute the Update to residents who wish to receive it.

As we continue to conduct facility-wide testing of all staff and residents regardless of vaccination status, one positive test result was received today from a test on August 9, 2021 for a resident who is fully vaccinated who lives on resident unit 3-200. 60 resident test results are pending from the tests this week. Our resident who tested positive was transferred to the 2-400 "C" positive unit. As of August 13, 2021, we have two staff with positive test results out of work (last test date of August 9, 2021).

Since we are in outbreak status conducting facility-wide testing, we must continue to suspend outdoor visitation. General indoor visitation must remain suspended until at least two additional rounds of testing of all residents and staff are completed. Compassionate or end of life visits may be scheduled at 11 am, 1 pm, 2 pm and 4 pm. Please call 973-585-2145 to schedule compassionate or end of life visits.

On August 11, 2021, Dr. James Pruden, St. Joseph Hospital met with staff. He shared his experience with COVID and his vast knowledge about the disease process and the benefits of vaccination. Vaccines were available and six staff were vaccinated. Thank you Dr. Pruden!

On August 18, 2021, we will administer COVID-19 vaccines to residents and staff who have received the first vaccine (Moderna) and who have consented to receive the second vaccine. Vaccines will also be available for unvaccinated residents or staff who wish to receive the vaccine and who provide written consent.
