## A Legacy of Caring since 1929

Update, January 22, 2021

Our Social Workers and Therapeutic Recreation staff distribute the Update to residents who wish to receive it.

When I joined the staff of Preakness in 2000, one of the first residents I met was our resident who passed away yesterday morning. He was one of our "young at heart" residents at 46 years old, with a chronic illness that he knew would be progressively debilitating over time. He brought with him professional experience from his career and after adjusting to his new life, used his experiences to advocate for residents as the President of our Residents' Council for 12 years. He served the Council during the time when the future of Preakness was under review and passionately "lobbied" for a new, state of the art, Preakness. He was a frequent participant at Freeholder meetings to make sure that the needs of the residents were known and he was appreciative when the decision was made to create a new Home. He was an award recipient as "Resident of the Year" by Leading Age NJ. We are extremely saddened by his passing and acknowledge his contributions to our Legacy of Caring and to our history. We thank our staff who have taken care of our long-time resident, a friend to many, and offer our condolences to his family and to his co-residents who have shared many experiences with him.

During this week's testing of residents, one resident who was admitted to our observation unit on January 19 and was tested on January 20, 2021 tested positive. Prior to admission, our resident received two negative test results. Two residents who were tested on January 21, 2021 tested positive: one resident from 2-400 who is on a tracheostomy and one resident from 3-200. Five residents are currently positive. Two results are pending for residents for weekly tests that were completed through January 21, 2021. In order to meet the needs of residents with respiratory conditions such as the need for a ventilator or tracheostomy, 2-400 "C" will be the COVID positive cohort rather than 3-400 "C".

411 staff were tested on January 20, 2021 and 115 staff were tested on-site on January 21, 2021. No staff tested positive. A nurse who works on 3-200 and was tested off-site, tested positive on January 22, 2021. Resident units on guarantine are as follows:

- Unit 1-400 through January 23, 2021
- Unit 3-400 through January 22, 2021
- Unit 1-200 through January 31, 2021
- Unit 3-200, "H" section through February 4, 2021
- Please note: Essential caregiver visitation is suspended on all units until there have been 14 days without a positive resident, facility-onset, case.

The second series of COVID-19 vaccination clinics with CVS are on January 24, January 25 and January 30,
