We hope you had a Happy Mother's Day! Many thanks to our staff who cooked and served the holiday meal, assisted with outdoor and virtual visits and deferred their own Mother's Day celebrations to take care of and to be with our residents.

Last week, we recognized our nurses during National Nursing week: "Nursing More than a Profession, It's a Calling". Our nurses demonstrate this calling every day and lead our interdisciplinary teams in the provision of care for our residents. May their work inspire others to pursue nursing as a calling! Our RN with the longest length of service has been with us since 1992 and our LPN with the longest length of service has been with us since 1993!

This week, we recognize all staff during National Nursing Home week: "Together Through the Seasons". As demonstrated each and every day during the Pandemic (and pre-Pandemic), all staff are essential in their roles to provide a Home for our residents.

Due to the decrease of COVID-19 activity to the moderate level in Passaic County (and throughout the State), staff will be tested once/week. On May 10, 2021, 426 staff were tested with antigen tests. One C NA who works on resident units 1-200/2-200 tested positive. Because all residents who were assigned to our CNA are fully vaccinated, residents with potential exposure were not placed on quarantine. Due to the positive test result, outbreak testing will continue and we cannot offer Essential Caregiver or social visitation at this point in time. Residents were tested yesterday and today. Results received to date are negative.

We currently do not have any residents who have tested positive. We have seven staff with positive test results out of work (last test date of May 10, 2021).

Our celebration of Cinco de Mayo on May 5, 2021 was postponed due to weather. We will celebrate with our residents and staff with a DJ Dance party on the rotunda patio on May 12, 2021.

On May 7, 2021 we said good-bye to our resident from 1-200 who joined our family during January 2021. He was the brother of one of our former staff. We thank the family for entrusting his care to us and wish we had had more time to spend with him. We offer our condolences to his family and to his co-residents and thank our staff who have taken care of our resident.
