Update, December 30, 2020

Please Note: This Update is posted on the Passaic County website, the Passaic County Facebook page, distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers and Therapeutic Recreation staff distribute the Update to residents who wish to receive it.

Yesterday and today, we received seven positive COVID test result for residents: six residents on our 1-400 resident unit from tests on December 28, 2020 and one resident on 1-200 who was tested on December 29. Our residents were transferred to the 3-400 C, COVID positive unit. As of this writing, 48 results are pending for residents for tests that have been completed December 28 through December 30, 2020.

Resident units 1-200, 1-400, 2-400 including the vent unit and Pathway are on quarantine. Please note: Essential caregiver visitation is suspended on all units due to the resident, facility-onset positive COVID cases.

293 staff were tested on Monday, December 28, 2020 and 414 staff were tested today using antigen tests. One C NA who works on several units tested positive today. Staff who are scheduled to work on Saturday, January 2, 2021 will be tested. All staff will be tested on Monday, January 4, 2021 and on Wednesday, January 6, 2021.

You may have read in the news about the students in the National Honor Society of Wayne Valley and the National Junior Honor Society of Anthony Wayne, the Confirmation students at Our Lady of the Valley Church in Wayne and their friends and families who collected donations and gifts for residents in nursing facilities. Due to their generosity, our residents received holiday gifts. On behalf of our residents, we thank and appreciate their efforts to remember our residents for the holidays.

We will wish our resident Marie Youngster a happy 105th birthday on January 2, 2021! Ms. Youngster was from Paterson before joining our family in January 2020.

Our vaccination clinic dates for the first administration of the COVID-19 vaccines on January 3, January 8 and January 9, 2021 and for the second administration on January 24, January 29 and January 30, 2021 were confirmed by CVS. CVS technicians will be on-site from 10 am to 4 pm. To date, we have registered 162 residents, 78 staff and 11 essential caregivers. Please call 973-585-2145 to speak with Lisandro Perez, Jr to schedule an outdoor visit, weather-permitting. At this point in time, outdoor visitation may occur for residents on units 2-200, 3- 200, 1-300, 2-300 and 3-400. Please be reminded that NJ has restrictions in place for those who travel from other states. Visitors from these states may not visit unless the person has completed the required quarantine period. You may also request an Essential Caregiver application from Mr. Perez for this type of future visit.

Virtual visits may be arranged by calling Alina Zalenski, Director of Therapeutic Recreation at 973-585-2124 or Lee Livingston, Senior Recreation Therapist at 973-585-2163. If there is a request for hair salon services, you may direct the request to Ms. Zalenski or Ms. Livingston.
