## **UPDATE ON VISITATION**

We have now received the results from the testing of staff and residents as required since the last positive test result on October 9, 2021 for a staff on resident unit 1-400. All results were negative. Therefore, effective October 22, 2021, general visitation may resume on all units except 1-400. Visitation hours are 10 am to 7 pm. These visits do not need to be scheduled. Two visitors at a time, ages two or older, may visit and all protocols for infection prevention must be followed. Visits may take place in a resident's room with the permission of a roommate, in the following areas if not in use by residents: activity rooms, sitting rooms, game room or library, or outdoors on the patio that is directly behind the main entrance. If you need assistance to transport a resident to the patio for an outdoor visit, please call 973-585-2145 to arrange for staff assistance.

For residents on unit 1-400, visitation continues as follows:

- Residents who are on transmission-based precautions may have scheduled compassionate or end
  of life visitation wearing all required personal protective equipment that we will provide. Outdoor
  visitation may not occur until the end of the precautions period.
- Residents who are not on transmission-based precautions may have scheduled compassionate or end of life visitation. Outdoor compassionate visitation may occur.
  - It may be possible to resume general visitation for residents on 1-400 on October 24, 2021.

Residents who are on transmission-based precautions on the observation unit on 2-400 or who are on transmission-based precautions on any other resident unit may schedule compassionate or end of life visits at 11 am, 1 pm, 2 pm or 4 pm. If you have special needs, please let us know. Please call 973-585-2145 to schedule the visits.

We are continuing to offer COVID vaccination clinics on-site for residents and staff. Residents and/or their designated representatives who have provided consent will receive the Pfizer vaccine on October 22, 2021. The next scheduled vaccination clinic is on October 29, 2021. Vaccinations will not be provided without written consent. Vaccination questions or messages may be left on the phone number dedicated to COVID-19 vaccination: 973-585-2100. To date, our vaccinations are as follows:

- Residents: 257 residents are fully vaccinated; two are partially vaccinated. 65 residents have received a Pfizer booster.
- Staff: Of our 500 staff, 420 staff are fully vaccinated; five are partially vaccinated. 85 staff have

received a Pfizer booster.

Flu vaccines will be administered to residents and staff during the week of October 22, 2021. Consent is required.
