Update, December 3, 2021

Please Note: This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers and Therapeutic Recreation staff distribute the Update to residents who wish to receive it.

As you may know from news reports, on November 30, 2021, a Federal judge in Louisiana granted a nationwide preliminary injunction to stop the Centers for Medicare and Medicaid Service's vaccine mandate for healthcare workers, noting the case will be heard in a higher court. Therefore, at this moment in time, there are not Federal requirements for healthcare workers to be vaccinated. New Jersey's current mandate allows staff to continue to be tested until vaccinated. Nevertheless, we encourage staff to be vaccinated. As has been the case throughout the Pandemic, protocols and requirements continue to evolve. As of November 30, 2021, this is the current information on mandatory vaccination for healthcare workers by the Federal government. Unvaccinated staff are tested twice/week.

Since the last Update on November 29, 2021, we have not had any additional positive cases of COVID. The confirmatory test for the one staff who tested positive on November 29, 2021 was positive. Residents on the 2-400 unit who were exposed to our staff member were tested on November 29, 2021 and the results were negative. The tests for residents will be repeated on December 6, 2021 and December 13, 2021.

Our next on-site COVID-19 Vaccination clinic will be on Friday , December 10, 2021. Pfizer, Moderna, Jansen (J&J) vaccinations are available for residents and staff for first, second or booster doses. Residents and/or their designated representatives who have provided written consent or verbal consent that is witnessed by two nursing management staff will receive the vaccines. To date, 257 residents are vaccinated; 159 have received a booster dose. 424 staff are vaccinated; 141 have received a booster dose. 68 staff are not vaccinated.
