

## PASSAIC COUNTY OPEN SPACE TRUST FUND ADVISORY COMMITTEE MINUTES OF A REGULAR MEETING Thursday, July 15<sup>th</sup>, 2021 WebEx Meeting

Chair Anne Kahwaty opened the meeting at 6:31 PM and read the notice that the requirements of the Open Public Meeting Act had been met. She then proceeded to the roll call.

**MINUTES**: A motion to adopt the minutes of the May 20<sup>th</sup>, 2021 meeting was made by Commissioner Lawson and seconded by Commissioner Canetti. The motion passed unanimously with a minor adjustment to correct a typo with Kathleen Caren's name.

**PUBLIC PORTION:** Commissioner Lawson made a motion to open the meeting to the public which was seconded by Commissioner Vroom. The motion passed unanimously.

Seeing no one present, Commissioner Vroom made a motion to close the public portion that was seconded by Commissioner Lawson. The motion passed unanimously.

## **NEW BUSINESS**

Planning Director Lysicatos provided an update on the Fall Grant Workshop. He stated that the department intends to work with Kelly Ruffel and the County Administration to examine the governing rules and make minor adjustments. This includes more guidelines on when applicants submit reporting, specifically having applicants submit reporting during the year. Staff is also looking to incorporate previously discussed guidelines on tree removal/replacement for new applicants. This will include having new applicants state if there will be tree removal as part of their project, and how they plan on mitigating the lost trees.

## **OLD BUSINESS**

Chair Kahwaty asked Planning Director Lysicatos to elaborate on the tree replacement policy discussed at the last Open Space meeting. Planning Director Lysicatos stated that the policy would probably take the form of asking the applicant if they planned on removing any trees during the application process. If the applicant stated that they intended to, the application would

also ask how the applicant intends to mitigate that tree removal; which could either be the applicant replanting on site, or planting trees elsewhere in the municipality. Open Space Coordinator Jessie Summers would speak with applicants to discuss what would be the most appropriate option for mitigation.

Chair Kahwaty asked about a previously discussed item regarding pickleball facilities in Passaic County. Planning Director Lysicatos stated that pickleball facilities were present at the following locations:

- Little Falls Sports & Recreation Complex
- North Haledon Pickleball Courts
- Holster Park, Clifton
- Albion Park, Clifton
- Dudiak Park, Clifton
- Clifton plans to build courts at Dunney Park and Ravine Park
- Woodland Park is also planning to construct pickleball courts
