Allocation Committee, Starr reported that the committee met on Wednesday, January 12, 2022, and the RFP that was out for the After School Prevention Program for \$44,999 closed today and there were no responses. This information will be presented to the Allocations and Planning Sub-Committees to see if they want to RFP it again or go through our visions and identify other services for youth and families for those allocated dollars.

Planning Committee, McCombs reported that she has published their 2022 meeting schedule and they will be reviewing provider profiles for those providers that want to make any changes to identify any gaps they may have.

Education, Training, and Advocacy Committee report, there was no report.

Youth Services Commission Administrators.

Vuksic stated that the state YSC are looking at the regulations and there is a healthy discussion going on.

Starr made some announcements:

- The Applicant Conference for the Restorative Transformative Pilot Program was held of January 5, 2022, which a couple of our YSC members attended, and applications are due on May 9, 2022.
- Listening Sessions (Restorative Transformative Bill) If you have a captive parent, family, audience, probation, professional staff and/or grass root organizations. We will be holding multiple listening sessions throughout the city, virtually, and at public libraries to hear from the community to make sure that we are planning properly.
- We will be establishing a Restorative and Transformative sub-committee

- Our By-Laws requires that all voting members participate in at least one sub-committee, if you are unable to participate, please afford staff or a designee that can participate on your behalf.
- Contract Packages were sent out in December, please make sure they are sent back by due date January 28, 2022.
- 2 Pre-Monitoring meetings will be scheduled with each provider, the first one is to help you understand the contract, objectives, and goals and the 2<sup>nd</sup> one is to pre-monitor the program to make sure we are all prepared for our official monitoring for 2022.

JJC (Juvenile Justice Commission) Compton-Dover stated that there is nothing to report on.

Juvenile Detention Alternatives Initiative, Nowling reported that the PEEP program is doing well, and they had a meeting on January 18, 2022, with the juveniles that will be participating in the program. Filko stated that he met last night with the 8 participants virtually and that the program is going well, and they are expecting 8 more participants to start.

Executive Committee, Heller reported that they do not have anything to report on at this time but will be going over recommendations for appointments for all the YSC Sub-Committees and present to the YSC in February. Starr further stated that the planning sub-committee is giving all providers the opportunity to sit down with them and be an active participant in the services that they are delivering. All providers make sure to take advantage of that.
