The monthly meeting of the Passaic County CIACC was called to order at 9:35am. The meeting was held via videoconference. *Minutes, agenda, and meeting link is available on the Passaic County website.*

I. **Minutes:** On a motion by Paulina Dutton and seconded by Jenny Sierra, February 9, 2022 minutes were approved.

II. System Partner Updates:

Paulina Dutton, Circle of Care CMO, reported 953 active youth, 68 new referrals, and 62 transitions. The RFP for Community Development Funds in the amount of \$68,000 is due by 3-22-22. https://circleofcarecmo.org/2022-2023-community-resource-development-funds-request-for-proposals-rfp/

- Kathi Champagne, FSO, reported total 84 referred, 22 visits with CMO, 23 without CMO, total 179 face to face virtual visits & some have taken place in-person. The support groups continue virtually, although the West Milford group has met once in person. Youth Partnership continue a hybrid schedule with 13 unduplicated youth in attendance.
 Bilingual FSP on March 1st. Nine Nurtured Heart Approach trainings, they now have 3 certified trainers.
- Donna Glinkin, CMRSS, handed in her report. They had 238 dispatches and are currently working with 350 families, and no petitions or shelter placements. They have staff and supervisor openings.
- Jeena Williams, DCPP reported on February, Central Passaic received 179 referrals, and Northern Passaic had 165 referrals. RFPs are on the DCF website including Psychiatric Community Home programs closing on March 17, and also for existing Out of Home Treatment Providers due on March 15. Also Request for Qualifications for Intensive In-Home Clinical Supports for youth with Intellectual & Developmental Disabilities.
- St. Mary's Seton Center has a new Partial Care Program for youth ages 11 to 17, Peace Program hopefully to start on March 28th. A flyer will be sent containing details around the program.

III. Committee Reports:

- Kathi Champagne reported that the Racial Equity's 3rd Youth Forum is taking place on March 22nd at the Al Moody Academy. The topic of discussion will be the Bridgewater Mall incident to start the discussion. We will use this conversation as a start discussion during virtual Forum in Partnership with the Boys and Girls Club in Paterson in April. Date to be determined.
- Joanna O'Rourke, PFS II, shared a copy of the logic model. Needs Assessment determined high problems with vaping and marijuana use in youth ages 9 to 17. They showed the root causes to be availability & access, and low perception of risk. The local conditions identified were underage sales, and the low perception of harm. As a workgroup, trying to decide on strategies and interventions to address the issue. Local interventions include creating awareness and education to parents in school; collaborate with business to education on consequences of early use; engage SACs in schools; and implement school-based programs on the dangers of vaping and marijuana use. Overtime evaluations will take place to determine successes.
- Ana Maria Rivera reported that Community Voice committee is meeting twice a month, on the second & last Tuesday of the month at 6:30pm. As Fanny Ochoa announced last meeting, she has moved from the county, so they are reorganizing, and the new vice-chair is Nancy La Torre. Fanny will still be available to provide support and her experience. They are preparing a proposal for family engagement and will send to Jenny Vuksic shortly. The group has been discussing DVRS and services for families. They have gathered testimonies from families that were requesting services through DVRS. They will have a meeting with volunteer partners to discuss concerns, DVRS was invited to have a meeting as well to address challenges. DVRS requested that concerns were sent in writing. Also, they are collecting information on parent's experience when they call the PerformCare.
- Planning/Education Committee: Continued discussion on the Promising Path to Success Funds, and discussion around engaging families in CIACC and subcommittees. Invited Iyana Anderson and Paulette Mader to our next meeting after CIACC, as well as individuals from Family Success Centers. They continue to address the rising numbers of referrals coming to the Emergency Room.

- IV. Youth Services Commission: Le'Var Starr reported that they are working on programs under YSC, the Probation Enrichment Education Program (PEEP) through PCTI as well as the Probation Orientation Program (POP). Under the State Community Partnership grant they partner with 12 agencies to provide 18 services. Seven of those in the Prevention Continuum, 5 in the Re-Entry continuum. YSC meets next week on March 16 at 12:30pm, notice of the meeting can be found on the website. They will be soon planning the annual Youth Service Conference. In collaboration with the Recreation Department in Passaic County and have established a Youth Leadership Retreat, and they are actively recruiting students. A letter for recruitment will be sent out to CIACC for referrals, they are looking take 20 students. Please refer those that may benefit from the program, and they will be bringing back 12 youth counselors that were trained last year. It is a 3-day/3-night retreat held at Passaic County Camp Hope.
- V. **Division of Mental Health & Addiction Services:** Bart Chou discussed Addiction Division RFPs and Mental Health RFPs. They always reserve some money for the family, youth adolescents for services. They have completed the RFP review and they are waiting on Commissioner approvals, which then can be presented.
- VI. **Stakeholder Updates:** It was questioned earlier if DCPP tracks where referral come from. Jeena was able to look into Data Hub which is available to the public. The latest data provided was from 2020. In 2020, the largest referral source was law enforcement. In 2019, the largest referral source was the school system. - VII. Announcements: Le'Var Starr asked for agencies to present their programs to the YSC. Also looking for professionals/agencies to join a panel discussion. They have been recently asked from Pompton Lakes School Board how youth is responding after covid. There are questions from the Councilmen & Superintendents how child and families are responding in school, have we seen any differences in behavior, etc. Literature can be sent to those interested.
