#### **Reports:**

Monitoring Committee, McFarlane reported that the monitoring committee will meet on Thursday, May 19, 2022 @ 9:30 AM via TEAMS

Allocation Committee, Starr reported that the committee met on May 11, 2022, and reviewed our current spending plan and identified a few vendors that may overdraw their current contract and allocation and we are developing a plan for that as well as those providers that may under draw their allocation. They also spoke about all the grant sources that are being managed. Starr further stated that if you are a YSC member who is not funded and would like to join the Allocation Committee, this would be an excellent opportunity for one to bring their experience and expertise to the group.

Planning Committee, McCombs stated that there are no updates but are starting to look at the Plan Update and their next meeting is scheduled for June 14, 2022, at 1PM via TEAMS.

Education, Training, and Advocacy, Bogert reported that they do not have any update but are working towards getting a working meeting scheduled.

Youth Services Commission Administrators, Le'Var reported the following:

- The Restorative Application was submitted to JJC on April 9, 2022, and JJC is currently reviewing the submission

Starr reported that the Commission and the Board need to be aware that it is the intent of CJJSI to go for the Innovations for the year 2023, they will be applying for those funds. It is the Commission's duty to approve or not approve for the CJJSI Committee to apply for the 2023 Innovations funding. Commission approved.

JJC (Juvenile Justice Commission) Williams stated that they did receive and reviewed the Restorative Transformative Justice Application and Passaic should be receiving feedback shortly.

Juvenile Detention Alternatives Initiative, Starr reported during YSC Administrator's report.

Chair report, Heller reported that she is happy that everything is moving along with monitoring.
