Update, June 27, 2022

Our Social Workers and Therapeutic Recreation staff distribute the Update to residents who wish to receive it.

Since the last Update, two staff tested positive for COVID-19. On June 24, 2022, one staff in an administrative support position tested positive. The one resident who was exposed to the staff has been tested and will be tested again following the CDC recommendations for testing. On June 27, 2022, one staff with maintenance responsibilities tested positive. Due to the nature of the staff's responsibilities, there wasn't close resident contact.

The current outbreak began on April 18, 2022. Eighteen staff and one resident have tested positive. Sixteen of the eighteen staff completed the primary series of vaccination; two have approved exemptions. Twelve staff received boosters; one received a second booster. We currently do not have any residents who are positive for COVID-19. We continue to follow all precautionary infection prevention measures and regulatory requirements.

COVID-19 vaccines are offered to residents and staff in accordance with current CDC recommendations. Please call Patrick Kuiken, RN, Infection Preventionist at 973-585-2181 for additional information. We have antigen tests available for visitors who wish to be tested prior to visiting. If interested, please inform Security staff when you arrive for the entrance screening.

Last week, we said good-bye to one of our residents who has been part of our family since December, 1992. We offer our condolences to her family and thank our staff who have taken care of her for twenty-nine years.
