Update, August 11, 2022

Please Note: This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers and Therapeutic Recreation staff distribute the Update to residents who wish to receive it.

One resident tested positive for COVID-19 since the last Update. Our resident lives on resident unit 1-300 and had a primary series of vaccination. With the exception of two residents who refused testing, all residents on 1-300 were tested and will be tested again following CDC requirements. All staff who worked on the 1-300 unit during the past 48 hr. are in the process of being tested and will also be retested following CDC requirements.

The current outbreak began on April 18, 2022. Thirty-seven staff and twelve residents have tested positive. Five of the staff are not vaccinated and have approved exemptions. Twenty-eight staff received first boosters; three received a second booster. Nine residents received a first booster; one received a second booster. One staff is currently out of work. Our residents who tested positive are residing on 2-400, "C" section, the section for residents who test positive for COVID.

COVID-19 vaccines are offered to residents and staff in accordance with current CDC recommendations. Please call Patrick Kuiken, RN, Infection Preventionist at 973-585-2181 for additional information. To date, 115 residents and 121 staff have received second boosters. Antigen tests are available for visitors who wish to be tested. Please inform the Security staff when visiting if you wish to be tested.

The New Jersey Long-Term Care Ombudsman has created a brochure about the rights of LGBTQI residents and residents living with HIV in New Jersey's long-term care facilities. Casino Day is scheduled for August 12, 2022. Games will include "Blackjack, Roulette, Poker and Slot Machines". Because we are in Outbreak status, participation is limited to residents and staff.

As a reminder, Passaic County has partnered with agencies and schools to provide donated school supplies to children. Donation receptacles are in our main and employee entrances for those who wish to donate supplies. Thank you for your anticipated generosity!
