## **MINUTES**

### **OLD BUSINESS**

## **Harper Turner Farm**

County Council Pogorelec reiterated that the board passed a resolution (Resolution 21-1) approving the applicant's request for a site-specific determination. The permit was to import fill dirt to create logging roads and create gardening beds. A motion was made by Commissioner Hazelman and seconded by Vice Chair Fenney to adopt Resolution 21-1. The motion passed unanimously.

### **OPEN DISCUSSION**

Chair Bartlett inquired about Oldham Road. Planning Director Lysicatos stated that a draft application was being put together and would be sent to the board before being sent to the state.

Chair Bartlett asked about the protocol for having a closed session. County Counsel Pogorelec outlined the procedure and circumstances in which a closed session could be used.

The board discussed possibly using the county facility at Nike Base to meet when meeting in person becomes feasible.

Commissioner Eelman asked if there was an update from the Battinelli Family Farm. CADB Administrator Summers stated that she had been in contact with the applicant. The applicant was working to get materials together to prove their commercial farm status. However, before the applicant could appear before the board, they must appeal the determination made buy the tax assessor.
