The monthly meeting of the Passaic County CIACC was called to order at 9:30am. The meeting was held via videoconference. *Minutes, agenda, and meeting link is available on the Passaic County website*.

I. **Minutes:** On a motion by Sybil Schreiber and seconded by Le'Var Starr, the May 11, 2022 minutes were approved.

## **II.** System Partner Updates:

• Paulina Dutton, Circle of Care CMO, in May reported working with 1,067 youth, 89 new referrals, and 80 transitions. Already in June 1,026 youth and 54 new referrals. Still working in hybrid schedule. Paulina thanked all who helped in the Healthy Bodies Healthy Minds event. Discussed the Juneteeth event they are holding on Friday with local historian Jimmy Richardson.

- Donna Glinkin, CMRSS, reported they had 276 requests for dispatches and are currently working with 420 families. Experiencing high numbers, 137 calls already in June. They currently have 2 staff openings.
- Jenny Sierra, DCPP, reported a total of 391 referrals from both DCPP offices. Passaic Central Office received 18 Child Welfare Assessments, and received 176 Child Protective Service Investigations, which is a total 194 referrals in May. Passaic Northern Office received 23 Child Welfare Assessments, and received 174 Child Protective Service Investigations, which is a total 197 referrals in May.
- Kathi Champagne, FSO, reported 92 new families referred, total of 182 hours face to face visits. They have added 2 bilingual PT Peer Support Partners, and a Transition Aide Specialist. Support Groups continue to thrive on a hybrid schedule once a month, West Milford location is meeting in person. They held 9 Support Groups in the month of May. 4 activities with the Youth Partnership Group. Working with Racial Equity Committee on the Youth Forums at ATM.

#### **Committee Reports:**

- Racial Equity reported on updates from the most recent in person Youth Forum at the Al Moody Academy on June 7th.
- Joanna O'Rourke, PFS II, reported that there were no updates. Jenny forwarded CIACC members a survey to complete on the progress of the Logic Model. It was submitted to NJPN and waiting for their response.
- Ana Maria Rivera, Community Voice, reported they are still meeting twice a month.
  They will be taking a break during the summer months. CIACC Planning approved
  flyers. Would like members to share within the community, and Jenny looking into
  printing. Working on information sent by Paulette on Getting to Know CIACC, will
  translate to Spanish. Hoping to engage families on understanding CIACC and how to
  participate.
- Planning/Education Committee: Will meet June 21<sup>s</sup> at 10:00am. Diahann discussed revamping approach to working with liaisons. Frustration looking for updated resources....PC Resource Directory, Impact Passaic, PassaicResourceNet, etc. A need to update resources/streamline communication with partners. Narine offered to present to liaisons on how to access resources. Discussion around having a county conference to speak to Education on this topic, liaison could include McKinney-Vento, parent liaisons, DCPP, etc. Discussed presentation for Educators & community members with how to access services for their family, a subcommittee to plan
- By-Laws & Membership: Jenny Vuksic let members know they are updating the CIACC By-Laws manual to present to the Mental Health Board Members for approval. Also, updating membership for the September meeting.
- III. **Youth Services Commission:** Meeting virtually today on Teams at 12:30pm. The youth Leadership Retreat is receiving referrals, and the retreat will begin 6-28<sup>th</sup> until 7-1<sup>st</sup>, taking place at Camp Hope. The YSC will have an opportunity to review the program on 6-30<sup>th</sup>. They have submitted the application for Restorative Justice pilot program, and have started some public meetings.
- IV. **Division of Mental Health & Addiction Services:** Bart Chou reported their goal for September is reaching out to schools and building their curriculums. The 2 curriculums are We're Not Buying It & Mental Health Fist Aid for youth. Working on having the Hope One Van to reach out to all the municipalities.
