Update, November 28, 2022

Please Note: This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers and Therapeutic Recreation staff distribute the Update to residents who wish to receive it.

On November 27, 2022 and November 28, 2022, two residents who live on resident unit 1-400 tested positive. One resident is in the hospital and one resident is residing on resident unit 2-400 "C" section until transmission-based precautions are discontinued. On November 28, 2022, two staff tested positive: one C NA who was returning from vacation and one Food Services Worker. We currently have six staff who tested positive who are out of work. Residents and staff who had close contact were tested and will be retested in accordance with regulatory requirements.

Patrick Kuiken, RN, Infection Preventionist is continuing to administer the bivalent booster vaccines to those who are eligible to receive the booster and who consent to receive it. To date, 195 residents (273 total residents) and 181 staff (445 total staff) received the bivalent booster vaccines. We began to "deck the halls" today for the holiday season with the installation of our rotunda Christmas tree. "Live" cut trees are a fire hazard and are not permitted.
