Update, December 6, 2022

*Please Note*: This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers and Therapeutic Recreation staff distribute the Update to residents who wish to receive it.

Since the Update on December 4, 2022, eleven staff tested positive: five staff from our rehab department, one security guard, one nurse from resident unit 3-200, one C NA from resident unit 1-400, one C NA from resident unit 3-400, one facilities staff and one nursing management staff. We are continuing to test staff twice/week until further notice. Residents who had close contact with the residents or staff who tested positive are retested in accordance with regulatory requirements. Residents who tested positive are residing on resident unit 2-400 "C" section until transmission-based precautions are discontinued. To date, since the beginning of the Outbreak on November 23, 2022, thirteen residents and twenty-four staff have tested positive. Ten of the thirteen residents are fully-vaccinated. Nine of the ten residents received the bivalent booster. The twenty-four staff are fully-vaccinated. Three of the staff received the bivalent booster.

With sadness, we share with you that the President of our Resident Council passed away on December 5, 2022. He joined our family in 2017, together with his wife who predeceased him. An avid gardener, he planted and cared for the vegetable garden in our entrance courtyard. Many will remember his life stories and adventures that he shared with us, his humor and the passion he had for his children. We offer our condolences to his family and thank our staff who provided for his care.

The resident events scheduled for December 7, 2022 (Holiday Karaoke) and December 10, 2022 (Holiday Music Party) will be rescheduled to later dates.

The Passaic County Board of County Commissioners in collaboration with Passaic County social services agencies are hosting a "Holiday Angel Tree Toy Drive" to provide toys to the YMCA of Paterson, the Paterson Great Falls Military Assistance Program and foster children in Passaic County. Donations of new gifts would be appreciated. The gifts do not need to be wrapped. Receptacles for the gifts are in our main entrance lobby and the employee entrance.

The Passaic County Board of County Commissioners in partnership with the NJ Department of Health is offering free COVID-19 test kits for Passaic County residents. There is a limit of two kits/person, while supplies last.
