**WHEREAS,** a regular meeting of the Passaic County Improvement Authority (the "Authority") was held on July 27, 2022;

**WHEREAS,** the Authority approved entering into a shared services agreement with the County of Passaic for general accounting services by way of Resolution R22-15, dated April 27, 2022;

**WHEREAS,** the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., authorizes the Authority to enter into an agreement with any other local unit or units, such as the County, to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive within its own jurisdiction;

**WHEREAS**, the County of Passaic and the Authority have now agreed on the form of the aforementioned shared services agreement; and

WHEREAS, the Authority desires to approve the form of the shared services agreement.

# NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE MEMBERS OF THE PASSAIC COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. The Authority hereby authorizes a shared services agreement between the Authority and the County and hereby approves the form of the agreement, as set forth attached hereto.
- 2. The Chairman is authorized and directed to execute the agreement substantially in the form of the agreement attached hereto and take all appropriate action to effectuate the agreement.
- 3. This resolution shall take effect immediately.

THIS SHARED SERVICES AGREEMENT (hereafter "Agreement"), dated this day of \_\_\_\_\_\_, 2022, by and between the County of Passaic, a body politic and corporate of the State of New Jersey (hereafter "County"), with its principal offices located at 401 Grand Street, Room 214, Paterson, New Jersey 07505, and the Passaic County Improvement Authority (hereafter "PCIA") is a public improvement authority of the State of New Jersey, with its principal offices located at 401 Grand Street, Room 417, Paterson, New Jersey 07505 (collectively referred to as the "Parties").

## **RECITALS**

**WHEREAS**, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners of the County of Passaic (hereafter "Board") is vested with managing the property, finances, and affairs of the County; and

**WHEREAS**, pursuant to <u>N.J.S.A.</u> 40:37A-44, <u>et seq.</u>, County Improvement Authorities Law, the Board approved Resolution No. R02685 creating the PCIA; and

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq., authorizes the County to enter into an agreement with any other local unit or units to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive within its own jurisdiction; and

WHEREAS, the PCIA is requesting to enter a shared services agreement with the County, whereby the County shall provide general accounting services to the PCIA for a minimum of five (5) hours per week at the rate of one hundred dollars (\$100.00) per hour, for a monthly amount of two thousand dollars (\$2,000.00), with an additional services rendered by the County to be billed at the hourly rate; and

WHEREAS, the term of the shared services agreement shall be for a period of ten (10) years, beginning May 1, 2022 and expiring April 30, 2032, with the County and PCIA retaining options to terminate same upon sixty (60) days' notice to the other party, upon notice, and

**WHEREAS**, pursuant to N.J.S.A. 40A:65-5, the Parties each adopted resolutions authorizing entry into this Agreement, copies of which are annexed hereto and made part of this Agreement.

**NOW, THEREFORE, BE IT AGREED**, in consideration of the promises, covenants, terms, and conditions hereinafter set forth, the Parties agree to perform in accordance with the provisions, terms, and conditions set forth in this Agreement as follows:

- 1. <u>Incorporation of Recitals</u>. The recitals set forth above are incorporated herein by reference.
- **2.** <u>Term.</u> The duration of any agreement under the Act shall be ten (10) years, beginning May 1, 2022 and expiring April 30, 2032.

- **3.** <u>Project Description.</u> The County shall provide the PCIA general accounting services, through its Department of Finance, for various budgetary and account services, as required on an as-needed basis.
- **4.** <u>County Responsibilities</u>. The County will provide the PCIA with general accounting services, which will include, but not be limited to, the following:
  - a. Maintain and reconcile the PCIA's general operating account on Quickbooks or other similar accounting program.
  - b. Maintain and reconcile the PCIA's bond accounts on Quickbooks or other similar accounting program.
  - c. Process the bills of the PCIA, specifically, receive bills, obtain proper purchase orders, create a bill's list for approval by the PCIA, and forward checks and payments to the appropriate vendors.
  - d. Process deposits of the PCIA, specifically, receive and deposit checks and post in the appropriate ledger, and process direct deposits and post in the appropriate ledger.
  - e. Coordinate with the PCIA's professionals to draft the PCIA budget on a yearly basis.
  - f. Coordinate with the PCIA's professionals to perform the PCIA audit on a yearly basis.
  - g. Attendance at PCIA meetings, as requested, that is anticipated not to exceed four (4) meetings per year, primarily in connection with the approval of the PCIA's yearly audit and budget.
  - h. Check and process correspondence of the PCIA on a weekly basis.
  - i. Coordinates arbitrate rebate calculations for PCIA bond deals in conjunction with the arbitrate rebate company hired by the PCIA.
  - j. Any other tasks reasonable related to the maintenance of the PCIA finances, as requested by the Executive Director and/or Chairman of the PCIA.
- **5.** <u>Time and Cost.</u> The County shall provide general accounting services to the PCIA for a minimum of five (5) hours per week at the rate of one hundred dollars (\$100.00) per hour, for a monthly amount of two thousand dollars (\$2,000.00), with an additional services rendered by the County to be billed at the hourly rate.

## 6. <u>Dispute Resolution</u>.

- a. <u>Mandatory Mediation</u>. In the event of a dispute, whether technical or otherwise, the objecting Party must request Non-Binding Mediation and the non-objecting party must participate in the mediation. The costs of such Non-Binding Mediation shall be borne equally by both Parties.
- b. <u>Procedure</u>. The Mediator shall be a retired Judge of the Superior Court of New Jersey or other professional mutually acceptable to the Parties and who has no current or on-going relationship to either Party. The Mediator shall have full discretion as to how to conduct the mediation. Each party shall participate in the Mediator's program to resolve the dispute until and unless the Parties reach an agreement with respect to the disputed matter, or one party determines, in its sole discretion, that its interests are not being served by the mediation.
- c. <u>Non-Binding Effect</u>. Mediation is intended to assist the Parties in resolving disputes over the correct interpretation of this Agreement. No Mediator shall be empowered to render a binding decision.
- d. <u>Judicial Proceedings</u>. Upon the conclusion of Mediation, any party may commence judicial legal proceedings in the appropriate division of the Superior Court of New Jersey. Venue shall be in the County of Passaic.
- e. <u>Temporary Injunctive Relief.</u> Notwithstanding the foregoing, nothing herein shall prevent a party from seeking temporary injunctive relief to prevent irreparable harm in the appropriate division of the Superior Court of New Jersey. Venue shall be in the County of Passaic.
- 7. <u>Employment Reconciliation</u>. No employees are intended to be transferred or terminated by virtue of this Agreement.
- **8.** Notice. All notices, reports, statements, requests, or authorizations required to be given hereunder shall be personally delivered or sent by first class mail to the Parties at the following addresses, unless a party has been notified of a change of address:

9. <u>Termination</u>. Each party shall have the right to terminate this Agreement upon sixty (60) days' written notice served upon the Parties by Certified Mail, Return Receipt Requested.

- 10. <u>Indemnification</u>. To the fullest extent allowable by the law, each party, their successors, and assigns shall hold harmless, indemnify, defend, and release the other party and their members, directors, officers, employees, agents, and contractors, successors and assigns from and against all suits, liabilities, penalties, costs, losses, damages, expenses or claims, including, without limitation, reasonable attorney's fees arising from or in any way connected with the other party's performance, attempted performance, or failure to perform in connection with this Agreement or other activities as described in the Agreement, including, but not limited to, any injury to or the death of any person or any damage to any property resulting from any act, omission, condition, or other manner related to this Agreement, regardless of cause, unless due to the negligence of any of the indemnified parties.
- 11. <u>Assignment</u>. The Parties may not assign its rights or obligations under this Agreement without prior approval via resolution of the Board of County Commissioners of the County of Passaic, and the PCIA.
- 12. <u>Severability/Waiver</u>. All agreements and covenants contained herein are severable, and in the event any of them shall be held to be invalid by any competent court, this Agreement shall be interpreted as if such invalid agreements or covenants were not contained herein.
- **13.** <u>Governing Law.</u> This Agreement is being executed and is intended to be performed in the State of New Jersey and shall be governed in all respects by the laws of the State of New Jersey.
- **14.** <u>Public Inspection.</u> A copy of this Agreement shall be available for public inspection at the offices of all Parties in accordance with N.J.S.A. 40A:65-4b.
- **15.** Filing with Department of Community Affairs. Pursuant to N.J.S.A. 40A:65-4b, this Agreement shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs.
- **16.** Entire Agreement. This Agreement contains all the terms and conditions agreed upon by the Parties and supersedes all other negotiations, representations, and understandings of the Parties, oral or otherwise, regarding the subject matter.
- 17. <u>Amendments and Modifications</u>. This Agreement may be amended only by an instrument in writing signed by the Parties and effective as of the date stipulated therein. For any amendment to be valid and binding on the County, it must be accompanied by a resolution authorizing same.
- **18.** <u>Force Majeure.</u> If either parties' performance of any of the provisions of this Agreement become impossible due to Force Majeure, that County will be excused from performing such obligations until such time as the Force Majeure event has ended and all facilities and operations have been repaired and/or restored.

- **19.** <u>Headings.</u> The Article and Section headings in this Agreement are included herein for convenience of reference only and are not intended to define or limit any scope of any provision of this Agreement.
- **20.** <u>Authority</u>. By the signatures below, the Parties execute this Agreement and confirm that they are mutually bound by and fully authorized and empowered to enter and bind their organization by all provisions contained therein.
