MINUTES OF THE BOARD MEETING OF SEPTEMBER 28, 2022

The meeting was called to order via virtual webex meeting at approximately 6 p.m. Pledge of Allegiance was said. Roll was taken. Commissioners Bradley, Glovin and Marco were present. New Business / Old Business

Mr. Tucci stated that the Authority has had discussions with the Paterson Charter School of Arts and Sciences. The Charter School is anticipating purchasing its current facilities and desires to finance the project through the Authority. Commissioner Glovin asked if there would be a County guarantee. Mr. Tucci stated that there would be no County guarantee. Chairman Marco asked if there was an issue financing a charter school project. Ms. Litzebauer stated that a charter school is difficult to finance, as its charter is only renewed for five years at a time but that it can be done. Commissioner Glovin asked if there was collateral. Mr. Tucci stated that the buildings and land would be the collateral. Mr. Tucci further stated that there was a significant amount of due diligence required before any final decision by the Authority.

Ms. Litzebauer stated that the Ringwood Board of Education is applying to purchase a school bus through the Authority's Banc Program. The paperwork has all been executed. The parties are only waiting for the final approval from the LFB, which is only being held up because of vacations by LFB staff.

Commissioner Glovin moved to adjourn the meeting. Commissioner Bradley seconded the motion. Motion carried unanimously.

RESOLUTION OF THE PASSAIC COUNTY IMPROVEMENT AUTHORITY ACKNOWLEDGING RECEIPT OF THE APPLICATION OF ILEARN SCHOOLS, INC. FOR THE PURCHASE OF ITS CURRENTLY LEASED FACILITIES SERVICING THE PATERSON ARTS AND SCIENCE CHARTER SCHOOL.

WHEREAS, a regular meeting of the Passaic County Improvement Authority (the "Authority") was held on October 26, 2022; and

WHEREAS, iLearn Schools, Inc. (the "Applicant") is the operator and parent entity of the Paterson Arts and Science Charter School (the "Charter School"); and

WHEREAS, the Charter School currently leases its facilities from a non-related third party; and

WHEREAS, the Applicant desires to purchase the facilities of the Charter School (the "Project") and further desires to finance the Project through the Authority; and

WHEREAS, the Applicant has delivered to the Authority an application for the financing of the Project, dated October 14, 2022 (the "Application").

NOW, THEREFORE, BE IT RESOLVED by the Passaic County Improvement Authority as follows:

- 1. The Authority acknowledges receipt of the Application and will undertake to review the Application. Any further action of the Authority is subject to review of any and all additional information that the Authority, or its agents, requests from the Applicant, including, but not limited to, review of financial information, engineering reports, architectural reports, feasibility studies, legality of the financing, environmental issues, related financings, the Applicant's operations, and any and all other document or item that may impact the Project or the Applicant. Receipt and review of any item requested by the Authority, or its agents, in no way requires the Authority to take any further action.
- 2. The adoption of this Resolution by the Authority does not obligate the Authority to undertake the financing of the Project. The primary purpose of the adoption of this resolution is to acknowledge receipt of the Application and to permit the Authority to undertake its due diligence with regard to review of the Application.
- 3. Prior to any further review of the Application, the Applicant must post with the Authority an escrow amount to be used for costs incurred by the Authority in connection with the Application's review and due diligence by the Authority, including, but not limited to, the cost of professional services associated with the Project. The amount of the initial escrow and the amount of escrow to be maintained by the Applicant will be determined by the Authority's staff.
- 4. This resolution will take effect immediately, but will be of no effect with regard to expenditures for Project costs paid outside the permitted reimbursement period set forth in Treasury Regulation Section 1.150-2(d)(2).
