Update, December 19, 2022

*Please Note*: This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers and Therapeutic Recreation staff distribute the Update to residents who wish to receive it.

Since the last Update, one resident and five staff tested positive. Our resident had close contact with our resident from unit 3-200 who tested positive on December 13, 2022. The staff include one C NA who works on resident unit 1-400, one staff from Therapeutic Recreation, one staff from Security, one staff from Environmental Services and one nurse who has not been in our Home since December 4, 2022. We are continuing to test staff twice/week until further notice. Residents who had close contact with the residents or staff who tested positive are tested in accordance with regulatory requirements. Residents who tested positive are residing on resident unit 2-400 "C" section until transmission-based precautions are discontinued. To date, since the beginning of the Outbreak on November 23, 2022, fifteen residents and forty-four staff have tested positive. We currently have two residents who tested positive who are on transmission-based precautions.

Patrick Kuiken, RN, Infection Preventionist is continuing to administer the bivalent booster vaccines to those who are eligible to receive the booster and who consent to receive it. He can be reached at 973-585-2181.
