Update, January 3, 2023

*Please Note:* This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers, Therapeutic Recreation staff and Unit Clerks distribute the Update to residents who wish to receive it.

With continued wishes for a healthy and happy New Year, this Update includes that four staff and one resident tested positive since the last Update: one Security Guard, one staff from Dietary, one C NA from resident unit 3-400, one C NA from resident unit 2-200 and one resident who lives on resident unit 2-200. Residents and staff who had close contact with the staff who tested positive are tested in accordance with regulatory requirements. Residents who tested positive are residing on unit 2-400 "C" section until transmission-based precautions are discontinued. We currently have three residents on resident unit 2-400 "C".

On December 28, 2022, Judith Persichilli, RN, BSN, MA, Commissioner of the NJ Department of Health, informed nursing facilities that the State and the Country are heading into another surge of COVID-19. She cited in her letter that the virus has been most deadly to those individuals who are over the age of 80. According to Commissioner Persichilli, it is imperative that every single eligible person in congregate settings has the most protection against the COVID-19 virus. She advised to follow infection prevention protocols and become vaccinated if eligible. To date, 80% of our residents and 46% of staff received the bivalent booster. *We will have a "vaccine clinic" on January 12, 2023 during the hours that staff are tested for COVID; specific information will be provided before this date. Residents or staff who wish to receive a vaccine before this date may contact Patrick Kuiken, RN, LTC-CIP, Infection Preventionist who is continuing to administer the vaccines to those who are eligible and who consent to receive a vaccine.
