Update, January 12, 2023

Please Note: This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers, Therapeutic Recreation staff and Unit Clerks distribute the Update to residents who wish to receive it.

Since the last Update, three staff tested positive: two Security guards and one C NA who works on resident unit 2-200. Residents and staff who had close contact with the staff who tested positive are tested in accordance with regulatory requirements. Residents who tested positive are residing on unit 2-400 "C" section until transmission-based precautions are discontinued. We currently have one resident on unit 2-400 "C".

The work to connect the solar panel equipment into our electrical system is *tentatively* scheduled for January 18, 2023 and January 19, 2023 during the hours of *11 am to 3 pm*. During these hours, our power will be supplied by our emergency generator. The emergency generator will supply power to life safety systems and emergency lighting. Resident equipment such as beds, concentrators, feeding pumps will be plugged into the red electrical emergency outlets before the work begins. Resident TVs will not be operational. Additional information will be provided when the plans are finalized.
