Our Social Workers, Therapeutic Recreation staff and Unit Clerks distribute the Update to residents who wish to receive it.

Thank you to Mark Zalenski for the Martin Luther King, Jr. presentation for our residents this afternoon. His narration of the slides he prepared that were accompanied by historical movies including speeches by Dr. King was very informative and inspirational!

Since the last Update, one nurse who did not work within the timeframe to have close contact with residents or staff tested positive. In addition, one resident who was admitted from home tested positive upon admission. Residents and staff who have close contact with residents or staff who test positive are tested in accordance with regulatory requirements. Residents who tested positive are residing on unit 2-400 "C" section until transmission-based precautions are discontinued. We currently have one resident on unit 2-400 "C".

The work to connect the solar panel equipment into our electrical system is confirmed for January 18, 2023, and January 19, 2023 during the hours of 11 am to 3 pm. During these hours, our electrical power will be supplied by our emergency generator. The emergency generator will supply power to life safety systems and emergency lighting. A technician from the generator company will be on-site. Resident equipment such as beds, concentrators, feeding pumps will be plugged into the red electrical emergency outlets before the work begins. Resident TVs will not be operational. The lunch menu for residents will be revised to provide the hot entrée at dinner, rather than at lunch time. The revised menu will be
