Motion passed with 15 yeses, and 1 abstention.

Planning Committee, Vince stated that the planning committee met on November 15, 2022, and went through the vision from the plan from two years ago. They went through all the items in the vision and looked at that to give guidance Allocations since there are additional funds coming in for next year and are asking Allocations to make some decisions as to where to go with that, but the Allocations committee will need guidance from the Planning committee to make sure that they are following the vision of their plan.

Youth Services Commission Administrators, Vince reported that there are 2 RFP's currently out, the 1st one is for RTJ (Restorative Transformative Justice) and there is an addendum that is going out and the due date was extended to December 15, 2022. The 2nd RFP out is for the Shelter Beds which has been historically provided by the Newark YMCA. If you are interested in applying for any of the 2 RFP's, you can go to the Passaic County website (bids portal) and download the information.

JJC (Juvenile Justice Commission) Baker reported that they have the revisions that Passaic County submitted for their 2023 Plan Update and is currently under review and it should be out to Vince and Starr to be vetted through them and any budget modifications to be submitted to JJC. Baker also stated that they needed more clarification on some outstanding items from the RTJ grant application. Lastly, Baker stated that she met with Kakkar regarding transitioning the new support with having Vince in supporting Starr and make sure everyone is on the same page to implement the pilot program to their best ability.

Juvenile Detention Alternatives Initiative, Nowling reported that they have not had a meeting and stated that the PEEP (Passaic Education Enrichment Program) will end their 2nd session on December 6, 2022,

and will resume next year in the Spring. Nowling then shared a rags to riches story about a former PCTI student.

Chair report, the chairs did not have any updates.

Commissioner's Report, Commissioner Best was not present.

A motion was made by Butterfield, moved by Nowling, and seconded by Pacelli to adjourn the meeting.
