A roll call brought the meeting to order at 5:07 PM.

Ruffel presented bid responses for the Rifle Camp Park Amphitheatre Improvements project. Thomas & Sons Builders LLC. was the only and lowest responsible bidder. Ruffel reminded the Trustees that this project was partially grant funded and that the remaining funds would be provided by the County through a project management agreement.

A motion was made by O'Connor and seconded by Bartlett to award a contract to Thomas & Sons Builders LLC. for the Rifle Camp Park Amphitheatre Improvements project.

Motion passed unanimously.

Under Committee Reports, Trustees reported on several items. For the Memorial Bench and Tree Program, O'Connor provided a list of trees and what areas the plantings would be most appropriate for. Further discussion and a meeting with the Parks Department will take place to finalize. Ruffel noted a new request for a tree and bench are forth coming. Under Programs and Events for 2022, Ruffel provided flyers for Passaic County Walks and Octoberfest. Nardone discussed the Passaic County Walks and O'Connor provided a reminder for a workshop at the end of the month. Events are winding down, and a new schedule and proposal for 2023 events will be presented at the next meeting.

Under Treasurer's Report, Ruffel gave an update on the state of the bank accounts. Accounts are in good standing.
