Our Social Workers, Therapeutic Recreation staff and Unit Clerks distribute the Update to residents who wish to receive it.

On April 9, 2023, a resident who lives on unit 1-400 tested positive. Our resident recently was readmitted following a hospital stay. Our contact tracing includes consideration of the hospitalization as possible exposure. We are contact tracing our staff and residents of the unit. Residents and staff who have close contact with staff or residents who test positive are tested in accordance with regulatory requirements. Our resident is residing on 2-300 on transmission-based precautions.
