Under Treasurer's Report, Seemon gave an update on the state of the bank accounts. Accounts are in good standing.

Under New Business, a few project and grant items were discussed. The first item was on authorizing an application to the Green Acres Grant Program for the Vreeland House Rehabilitation and Site Improvements project. The project is set in Highlands Meadow Park in Ringwood, NJ and includes reuse of the site to serve the community with programs and a visitor center. An outline of plans was presented.

A motioned was made by Nardone and seconded by Pascrell to approve resolution 23-01.

There was discussion of Resolution 23-02, authorizing an application to the New Jersey Cultural Trust for a Capital Preservation grant in the amount of \$40,000 for Dey Mansion. There is no match to this new grant program.

Seemon presented a request by the Parks Department for funding the installation of a new putting green at Preakness Valley Golf Course.

A motion was made by Nardone to approve the request, seconded by Bartlett.
