Please Note: This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers, Therapeutic Recreation staff and Unit Clerks distribute the Update to residents who wish to receive it.

At this point in time, we have revised our internal mask policy as follows. *Masking requirements are subject to change based on public health emergency status, outbreak status, and/or community transmission levels.*

Staff

- Staff will continue to follow universal masking and will be required to wear source control (masks) when inside the building. Staff are not required to wear masks when in outdoor areas of our Home.
- Dietary staff are not required to wear masks when working in the kitchen area. Masks must be worn upon exiting the kitchen. Dietary staff may choose to continue wearing masks.
- N95 respirators must be worn when working with residents with confirmed or suspected COVID-19 infection and with residents on Transmission Based Precautions when an N95 is required. N95 respirators are available in the Nursing Office and at point of care in PPE carts.

Residents

- Residents are not required to wear masks except as follows:
 - Masks may be required for large indoor gatherings.
 - Newly admitted residents who do not meet immunization criteria may be required to wear a mask during care for a specified period following admission.
- Residents may choose to wear a mask. Masks are available upon request from unit nurses.

Visitors

- Visitors must wear masks at all times when in common areas.
- Masks may be removed while in outdoor areas, or when in a private location with residents, with permission of the resident/representative and roommate (if roommate is present).

Our holiday family dinner celebrations will resume on Mother's Day, May 14, 2023. Each resident may invite three guests to dine with them in the main dining room at 12 noon or 1:30 pm. Mindful of COVID precautions, seating is limited. Entrée selections are Cornish Hen or Cheese Lasagna. Reservations will be accepted until May 9, 2013.
