Update, June 8, 2023

*Please Note:* This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers, Therapeutic Recreation staff and Unit Clerks distribute the Update to residents who wish to receive it.

On June 7, 2023, a resident who lives on resident unit 1-300 tested positive. Residents and staff who had close contact with our resident were tested and will be retested in accordance with regulatory requirements. Our resident is residing on resident unit 2-300 on transmission-based precautions. Two staff who tested positive on June 3 and June 5, 2023 remain out of work on transmission-based precautions.

Our updated internal mask policy includes that staff are required to wear masks when providing care to residents or when prolonged close contact (15 minutes within 6 feet) with a resident is anticipated. The wearing of masks by residents or visitors is optional except when participating in large indoor gatherings. Anyone who has been exposed to COVID-19 or who has respiratory symptoms must always wear a mask. Masks are available from security staff in the main entrance and on resident units. Rapid COVID-19 testing is available upon request.

The New Jersey Department of Health continues to urge residents and staff to become vaccinated as the safest and most effective protection against COVID-19 and its variants. The project to upgrade the fire alarm system began on May 30, 2023. Resident units 2-400 and 2-200 are completed. Residents will return to the vacant 2-400 "B" section upon inspection/approval of the work by the regulatory authorities. During the time the rooms have been vacant, our Facilities and Environmental staff took the opportunity to paint and thoroughly clean each room.
