Update, June 13, 2023

Please Note: This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers, Therapeutic Recreation staff and Unit Clerks distribute the Update to residents who wish to receive it.

On June 12, 2023, a C NA who works on resident unit 3-400 tested positive. Residents and staff who had close contact with our C NA were tested and will be retested in accordance with regulatory requirements. We currently have one resident who is residing on resident unit 2-300 on transmission-based precautions and one staff who is out of work on transmission-based precautions.

On June 12, 2023, Governor Murphy issued Executive Order #332 which rescinds the requirements for healthcare workers to be vaccinated, including with a booster, against COVID-19. This is consistent with the June 5, 2023 Final rule by the Centers for Medicare and Medicaid Services to rescind the CMS requirement of Medicare and Medicaid certified providers and suppliers' staff to be vaccinated. Despite the rescinding of the mandate, residents and staff are urged to become vaccinated as the safest and most effective protection against COVID-19 and its variants. The project to upgrade the fire alarm system began on May 30, 2023. Resident units 2-400, 2-200, 3-400 and 3-200 are completed. Residents will return to the vacant 2-400 "B" and 3-400 "B" sections upon inspection/approval of the work by the regulatory authorities.
