Reports:

Monitoring Committee, McFarlane stated that they will schedule a meeting soon and completed 2 monitoring visits to City of Passaic Police Department's SHAP and PEEP (Probation Education Enrichment Program). McFarlane further stated that they have two monitoring scheduled this month: Center for Family Services FCIU (Family Crisis Intervention Unit) @ 1PM on April 20, 2023, and Mental Health Center of Passaic on April 27, 2023 @ 1:30 PM. Vuksic will send out a sign-up sheet for volunteers as soon as the other sites are scheduled.

Allocations Committee, Starr stated that the allocation sub-committee did not meet but will meet next month.

Planning Committee, McCombs stated that the 3-year planning is in full force. Surveys were sent out to all folks, and highly recommend that everyone complete them and send them in for data and planning purposes (this year parents will be included to complete surveys).

Youth Services Commission Administrators,

- Starr stated that all providers send in their 2023 contracts if they have not done so already

JJC (Juvenile Justice Commission) Compton-Dover stated that a provider was identified to create the blueprint for Passaic County's RTJ grant (New Destiny Family Success Center) with JJC (Juvenile Justice Commission) support. Compton-Dover also stated that this year is a planning year where the whole Comprehensive Plan must be redone. Compton-Dover also stated that the Passaic County's new parole team wants to be part of the Youth Services Commission.

Juvenile Detention Alternatives Initiative, Filko stated that she did not have any updates.

Commissioner's Report, Commissioner Cruz introduced himself to the commission and reported that on Friday, April 28, 2023, the County is having an all-day Public Service Conference at the Police Academy and food will be provided.
