

# PASSAIC COUNTY AGRICULATURE DEVELOPMENT BOARD MINUTES OF A REGULAR MEETING Tuesday, January 17<sup>th</sup>, 2023 WebEx Meeting

# **MINUTES**

# **OPEN DISCUSSION**

David Zaback from the SADC gave an update on SADC activity. He stated that a former Stewardship member has been promoted to SADC Deputy Director. As such, a position for Stewardship was now open. He also stated the SADC Executive Director would be reaching out to counties to have discussions on relevant activities and partnership between the SADC and county organizations. He also stated that preserved farms were eligible to grow cannabis and continue to maintain their preservation status; however, farms would not be eligible for preservation if they are growing cannabis at the time of their initial assessment.

Commissioner Roberts asked if Passaic County would be receiving a study from the Land Conservancy that Bergen County had received. Planning Director Massiel responded that the county was looking into doing inventory of the county which would bring Passaic County closer to a full Agriculture Plan. She also stated that the County Commissioners were considering folding the Agriculture Plan into the Open Space Trust Fund Plan.

**ADJOURNMENT**: Commissioner Hazelman made a motion to adjourn the meeting at 6:47 PM that was seconded by Commissioner Feeney. The motion passed unanimously.
