A roll call brought the meeting to order at 4:33 PM. Freeholder Bartlett participated in the meeting telephonically.

A motion was made by Secretary-Treasurer Jordan and seconded by Trustee Silva to approve the minutes of the April 18, 2016 meeting.

Secretary-Treasurer Jordan gave an update on the bank account, fundraising for the Fair, the 2015 Draft Audit, payments made to the Paterson Fire Department for the fireworks permit and to Party City for 50/50 tickets, and distributed an updated budget and sponsorship donations thus far for the Fair.
