**RESOLUTION AUTHORIZING AN INCREASE IN APPROPRIATION UNDER THE SHARED SERVICE AGREEMENT BETWEEN THE COUNTY OF PASSAIC AND COUNTY OF MORRIS FOR JUVENILE DETENTION SERVICES, PURSUANT TO N.J.S.A. 40A:65-1, ET SEQ.**

**WHEREAS**, the County of Passaic (hereafter “County”) is a body politic and corporate pursuant to N.J.S.A. 40:18-1 and vested with all rights contained therein; and

**WHEREAS**, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners of the County of Passaic (hereafter “Board”) is vested with managing the property, finances, and affairs of the County; and

**WHEREAS**, the Department of Human Services (hereafter “Department”) is an umbrella social service agency concerned with planning and funding services for disadvantaged and homeless citizens; and

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq., authorizes the County to enter into an agreement with any other local unit or units to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive within its own jurisdiction; and

**WHEREAS**, on April 12, 2022, the Board passed Resolution No. R20220280, authorizing a shared services agreement with the County of Morris, for the detention of Passaic County juveniles at the Morris County Juvenile Detention Center, at a rate of two hundred seventy-six dollars (\$276.00) per juvenile per day, in a total amount not to exceed thirty thousand dollars (\$30,000.00) for the calendar year 2022

**WHEREAS**, the Department is now requesting that the Board increase the appropriation under the shared services agreement with the County of Morris by one hundred thousand dollars (\$100,000.00) for a new total of one hundred thirty thousand dollars (\$130,000.00); and

**WHEREAS**, funds are available in Account No. 2-01-27-170-002-213 or any other account that may be deemed appropriate by the Chief Financial Officer or his designee, and the availability of funds has been contingently certified by the Chief Financial Officer subject to sufficient funds being appropriated by the Board in the 2022 and/or subsequent years’ County budget(s), which is attached to and made part of this Resolution; and

**WHEREAS**, this matter was discussed at the June 22, 2022 meeting of the Health and Human Services Committee and is being recommended to the Board for approval; and

**NOW, THEREFORE, LET IT BE RESOLVED**, pursuant to N.J.S.A. 40A:65-1, et seq., that the Board of County Commissioners of the County of Passaic hereby authorize the increase in appropriation under the shared services agreement between the County of Passaic and the County of Morris, by one hundred thousand dollars (\$100,000.00), in a new total amount not to exceed one hundred thirty thousand dollars (\$130,000.00) for the calendar year 2022.

**LET IT BE FURTHER RESOLVED**, that the Clerk to the Board, County Counsel, and Director of the Board are authorized to take any other action necessary to carry out the purposes of this resolution.


