#### March 2021

- Passaic County Behavioral Health Task Force was formed, next meeting will be held 3/11/2021 to help mitigate Mental Health and Addictions issues within the County.
- A proclamation from NJ State was received, announcing March 2021 Gambling Awareness month.
- "Hope One" van was delivered and in the process of being wrapped with the logo. The supplies for retrofitting are due to be delivered to the company soon. On 3/3/2021,
  Passaic County Commissioner Director visited the site of the project where Narcan kits and dignity kits were handed out.
- Jail MAT program coordinator resigned which requires the need to hire a replacement.
- Application to the State was submitted by "Prevention is Key" to receive Free Narcan Kits to provide to the appropriate high-risk population.
- The State provided updated OORP-Overdose Recovery Program data.
- IDRC (Intoxicated Driver Recover) program are providing virtual classes.
