February Notes

- "Hope One Van" will be escorted by the County of Passaic Sheriff's department. Scheduled dates and locations will be available shortly in February.
- DMHAS announced the eligibility of Behavioral Health employees to receive the Covid-19 vaccine.
- DMHAS announced the start of 988 Suicide Prevention emergency hotline.
- Vaccination sites will have a Disaster Response Crisis Counselor to assist with any emotional distresses.
- NJ State still has the Hope and Healing free emotional support hotline.
- Resolutions on renewing Mental Health RFP's and grants for CY 2021 were passed.
- State Addictions Grant Application for FY2021 is pending approval.
- Mental Health and Addiction Services Director will share information when available on the Prosecutor's Office Mental Health Task Force start date.

County Alliance Steering Subcommittee

- No CASS meetings have been conducted yet in 2021 due to no programs being held.
- Quarter 4 from FY2020 has been closed and reimbursements are now in process.
