RESOLUTION AUTHORIZING A SHARED SERVICES
AGREEMENT BY AND BETWEEN THE COUNTY OF PASSAIC
PRIVATE INDUSTRY COUNCIL D/B/A THE ONE STOP AND
THE COUNTY OF PASSAIC FOR STORAGE OF ARCHIVED
RECORDS BELONGING TO THE ONE STOP

WHEREAS the Board of Chosen Freeholders of the County of Passaic set up and incorporated the Private Industry Council of the County of Passaic many years ago, doing business as the Passaic County One Stop (hereafter referred to as the One Stop), as a non-profit separate corporation to conduct employee training and placement of residents of Passaic County principally funded through New Jersey State grant funding; and

**WHEREAS** the said One Stop has approached the County about providing a storage area for some of its archived records at the County of Passaic River Street warehouse facility; and

WHEREAS the County Administration has suggested that the said One Stop pay \$100 per month plus One (\$1) Dollar per box, which would include pickup and delivery of records, storage of boxes, retrieval of boxes and destruction of such records upon the direction of the One Stop, retroactive to July 1, 2019; and

**WHEREAS** since said One Stop, as mentioned above, is a separate corporation, it would be appropriate to handle this under a short Shared Services Agreement which is authorized pursuant to N.J.S.A. 40A:65-1 et seq.; and

WHEREAS this matter was reviewed by the Freeholder Committee for Finance & Administration at its August 28, 2019 meeting and recommended for approval by the full Board.
