RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT BETWEEN THE COUNTY OF PASSAIC AND THE CITY OF CLIFTON TO REPAIR THE SANITARY SEWER MAIN AT THE DAVIDSON AVENUE BRIDGE NO. 1600-056, PURSUANT TO N.J.S.A. 40:20-1

WHEREAS, the County of Passaic (the “County”) is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq.; and

WHEREAS, pursuant to N.J.S.A. 40:20-1, the Passaic Board of County Commissioners (the “Board”) is vested with the powers to make all decisions on behalf of the County; and

WHEREAS, the Passaic County Engineering Department is responsible for protecting and enhancing the quality of life of County residents through various infrastructure projects, including bridges, culverts, drainage systems, and road/traffic operations; and

WHEREAS, the County Engineer is recommending repairs to the Davidson Avenue Bridge No. 1600-056 over Weasel Brook in the City of Clifton (“City”) due to damages caused by Hurricane Id, the County is also preparing to award a contract to Colonnelli Brothers, Inc., to perform the repairs; and

WHEREAS, the City has requested that the County incorporate sanitary sewer main repairs in the contract involving Colonnelli Brothers, Inc., that will include Abutment Modifications/Beam Installation and Sanitary Pipe Replacement with CL 52 DIP Cement Lined and Temporary Bypass, and said items will be reimbursed to the County in the amount of not to exceed forty thousand dollars (\$40,000.00) in accordance to the terms of the Shared Service Agreement between the County and the City; and

WHEREAS, this matter was discussed at the July 26, 2023, Public Works Committee meeting and is being recommended to the Board for approval; and

NOW, THEREFORE, LET IT BE RESOLVED, pursuant to N.J.S.A. 40A:65-1, et seq., the Board of County Commissioners of the County of Passaic hereby authorizes the Shared Service Agreement between the County of Passaic and the City of Clifton where the County agrees to make repairs to the Davidson Avenue Bridge No. 1600-056 over Weasel Brook, including repairs to the City’s sanitary sewer main, and the City agrees to reimburse the County for the items necessary to the repair the sewer main, including the Abutment Modifications/Beam Installation and Sanitary Pipe Replacement with CL 52 DIP Cement Lined and Temporary Bypass in an amount not to exceed forty thousand dollars (\$40,000.00).

LET IT BE FURTHER RESOLVED, a copy of the maintenance agreement shall be filed, for informational purposes, with the Division of Local Government Services.

LET IT BE FURTHER RESOLVED, that the Clerk to the Board, County Counsel, and Director of the Board are authorized to take any other action necessary to carry out the purposes of this Resolution.
