Update, December 1, 2023

Please Note: This Update is posted on the Passaic County website and distributed through the Constant Contact email group for families who have elected to provide their email address and is distributed to all staff. Our Social Workers, Therapeutic Recreation staff and Unit Clerks distribute the Update to residents who wish to receive it.

This Update includes that ten residents and one staff from resident unit 3-200 tested positive today. Seven of the ten residents received the new monovalent vaccine. All residents of unit 3-200 were tested and all staff who work on this unit are in the process of being tested. Residents and staff will be retested in accordance with regulatory requirements. Residents who tested positive are residing on unit 2-300 until transmission-based precautions are discontinued. During the contact tracing we learned that a visitor also tested positive today. Antigen tests are available at no cost for visitors who wish to be tested. Please inform the Security staff when visiting if you wish to be tested.
