As the year comes to an end, we wish you Happy Holidays and a Happy New Year! We offer our immense thanks to our staff for the care and companionship provided to our residents this year.

At this point in time, we do not have any residents who tested positive for COVID-19. One staff member in a support position tested positive on December 18, 2023. One C NA who works on resident unit 2-400, respiratory section, tested positive on December 22, 2023. Residents and staff who had contact with our C NA were tested on December 22, 2023 and will be retested on December 24, 2023. The results were negative. We continue to test residents or staff who have symptoms of respiratory illnesses or have contact with residents or staff who test positive. Antigen tests are available at no cost for visitors who wish to be tested. Please inform the Security staff when visiting if you wish to be tested.

Until further notice, staff must wear masks at all times. Visitors and residents are strongly encouraged to wear masks.
