County Division of Mental Health & Addiction Staff Report Mental Health & Addictions Updates

June 2020

• The Innovation Grant has one applicant, Prevention is Key. DMHAS preliminarily extending contracting deadline for this award until August 31, 2020 to conclude by August 31, 2021.

- Division Director in discussions with providers to address concerns of access to mental health and addiction services in Upper Passaic County. New Life is interested in applying for IOP services once again in Upper County. IOP will be re-bid.
- Division Director still awaiting county approval to hire a Health Educator.
- Upcoming Federal Pathways to Employment Grant to be released. May be over \$650,000 for 18 months. Looking for a lead person or entity to get partners together to start planning to apply.
- Return to Work plan for our department starts on 6-15-20.

County Alliance Steering Subcommittee (hereafter "CASS") Report

• GCADA Update – FY20 – Funding Freeze

- Due to the reduced DEDR collections, there remains a freeze to Municipal Alliance programming and countywide activities that will stay in place until 9/30/2020
- GCADA plans to reimburse the Municipalities for the 5th Quarter Municipal Alliance Coordination through 9/30/2020.
- GCADA will be extending the FY2020 County contracts until 9/30/2020. GCADA is waiting
 final guidance from Treasury on the extension process. Once GCADA receives final guidance
 further instructions will be furnished to the counties.

• GCADA Update FY2021-2025 Planning Cycle

- o The FY21 will have 3 quarters and will begin on 10/01/2020 and end on 6/30/2021.
- The FY2021 County Awards will be revised and reduced based upon the reduction in the DEDR collections.
- Once the final projects are made by OMB, GCADA will release the revised awards to the County staff.

• Alliance Update

o The Alliances have continued to meet virtually.

May 2020

- The Innovation Award RFP has been posted. Bids are due on 5/22/2020.
- Mental Health and Addiction agencies are coping best they can with the immediate change to telehealth with limited access to the technology needed to get this done. FCC released grants to assist with technology and telehealth challenges that this pandemic has created.
- Deployment of Disaster Response Crisis Counselors (DRCC's) telephonically and at William Paterson University's Testing Site for the past several weeks. Division Director has been providing support and resources to the volunteers and provided cards with emotional support number in English and Spanish for the residents being tested.
- Division Director meeting with Paterson's Overdose Response Team & Coalition of Opioid Assessment and Response team to find best ways to tackle the Opioid concerns in Paterson.
- Challenges with mobile outreaches are being addressed.
- RFQ's for providers in Passaic County to identify what MH and Addictions services they could provide in the county.
- FEMA grant funding available for pandemic related disaster crisis counseling.

- News Letter was sent in Guidance Regarding Telemedicine/Telehealth and Telecommunication Support Services forBehavioral Health Provider Agencies Dealing with COVID-19In light of Coronavirus (COVID-19) public health concerns, both State and Federal declarations of emergency, and recent actions at the State and Federal level to support the use of telemedicine/telehealth during this public health emergency, the Division of Mental Health and Addiction Services (Division) is recommending that Mental Health (MH) and

Substance Use Disorder (SUD) provider agencies (PAs) consider providing programming through telemedicine/telehealth to the extent practicable and where appropriate.

- DEPT. OF HEALTH ANNOUNCES NEW HOSPITAL VISITORS POLICY
- Department of Health Commissioner Judith Persichilli announced a new policy on April 25th requiring hospitals to allow a designated support person to be with a disabled patient during hospitalization. This designated support person can be a family member, personal care assistant or another disability service provider knowledgeable about the patient's care and must be allowed to remain with the patient while in the hospital, subject to the restrictions. The patient's disability may be due to altered mental status, intellectual or cognitive disability, communication barriers or behavioral concerns.
- DISABILITIES RIGHTS NJ TO HOLD VIRTUAL TOWN HALL MEETING
- DRNJ the State's Protection and Advocacy will be holding a virtual listening session on Wednesday, April 29, 2020, 7:00 PM 8:00 PM to hear about what is working and what is not in the time of COVID-19. This listening session is an opportunity for individuals with serious mental illness, their advocates, and family members to speak to DRNJ and one another, and to promote the sharing of resources, information, and experiences. - The COVID-19 crisis is putting first responders at a dangerously high risk for a variety of mental health problems, psychiatric experts say. - the process during this COVID19 Pandemic for some of the BOSS have limited office hours, but all BOSS have active phone lines where messages are to be left and someone is to return calls to the community. Please see attached for your individual counties.

- Medicaid Alert: Effective April 1st 2020 all Prior authorizations for CSS and Substance use disorder services for Medicaid consumers have been suspended until further notice.
- DMHAS distributed a small supply of N-95 Masks and gloves to priority providers, based on frequent contact with consumers: Opioid Treatment Providers (30) and Non-hospital based Designated Screening Centers (10). As more supplies become available, the next target group of providers to receive supplies is residential providers with COVID-19 positive residents.
- To complement the COVID-19 helpline operated by the Mental Health Association of New Jersey (866-202-HELP), a helpline is now operational for individuals who are deaf or hard-of-hearing. That helpline is operational Monday Friday from 9 to 5 (973-870-0877).
- DMHAS contracted providers have submitted their required attestations asserting they will
 continue operations and continue to accept admissions, and have received their April contract
 payment as specified in the DMHAS March 25, 2020 correspondence. DMHAS staff continue to
 have frequent contact with our contracted providers to ensure the availability of services to our
 consumers.
- DMHAS has submitted our grant application to FEMA for the Immediate Service Program and to SAMHSA for the Emergency Grant to Address Mental and Substance Use Disorders During COVID-19.
