In the absence of the Chair and Vice-Chair, Francine Vince, Passaic County Department of Human Services Director brought the meeting to order at 5:15 PM.

Ms. Vince provided the Mental Health and Addiction Services Director Report in Brenda Browne's absence (see attached). Notably, Ms. Vince informed the Board that Member Barbara Westerberg resigned effective immediately.

Ms. Vince reported that the initial RFP for Passaic County Addiction, Prevention, Early Intervention, Treatment, and Recovery Support Services was released in January for a February 7, 2019 due date. The RFP was seeking vendors to provide 13 projects totaling \$711,111.00.

Ms. Vince reported that RFP's were not received for the following services:

- Medical Assisted Treatment (MAT)
- Outpatient (OP) Lower Passaic County
- Intensive Outpatient (IOP) Upper Passaic County
- Intensive Outpatient (IOP) Lower Passaic County
- Halfway House (HH) Male
- Halfway House (HH) Female
- Recovery Support Services
- Employee Assistance Program (EAP)

These services were put out for re-RFP February 21, 2019 for a March 15, 2019 due date.

The RFP's received were reviewed by the Proposal Review Committee. The Committee provided a "Proposal Review Committee Report" with funding recommendations (see attached). The LACADA reviewed the Report.

A motion was made by Ronna Bouton and seconded by Dalton Price to approve the Proposal Review Committee Report and recommendations to award services.

Mental Health & Addictions Updates

- Fee-for-Service (FFS) Oversight Board kick-off was 2/22/19 for NJ Division of Mental Health and Addiction Services (NJDMHAS). They report to the Office of Legislature and the Governor's Office. It is not an open meeting. Renee Burawski is the liaison between that board and NJDMHAS.
- Pompton Lakes and Ringwood have recently been designated as Stigma-Free municipalities. The municipalities yet to join are (West Milford, Wanaque, North Haledon, Haledon, Prospect Park, Totowa and Passaic). Our Division Director and Substance Use Navigators are working with residents of West Milford, Wanaque, North Haledon and Passaic who have expressed interest in joining the Stigma-Free movement.
- Office based addiction treatment is moving forward. Trainings will be posted soon for Practitioners/Prescribers. Trainings are free and open to physicians, APNs and Physician Assistants. Helps to prepare them for the waiver to prescribe Buprenorphine. Meeting was reportedly well-received by the practitioners who attended the meeting. NJDMHAS target to have 1000 practitioners trained within the next year. There will be a trainer for Northern NJ and one for the Southern NJ.
- Media awareness campaign about opiate use disorder will be kicking off soon. The campaign will be promoting Medication-Assisted Treatment.
- Reach NJ will be relaunched and will be a part of this campaign. Targeting the Reach NJ calls so they go to the Interim Managing Entity (IME). People searching for services will not be warm hand-offed to another call. Governor's \$100 million will be rolling out soon. Request for Proposals (RFP) coming up in 1.5 months for lease-based housing and sober living.
- Peer services and case management to be reimbursable July 1. No regulations yet for peer services. The State Professional Advisory Committee (PAC) will be convening to discuss.

The County received proposals for projects under this offering. All agencies submitted impressive applications for consideration. The Proposal Review Committee provided a thorough, comprehensive review of all submitted proposals and recommend the following:

Detoxification Program: There were two proposals received for this project. The agencies that applied for this project were: Straight and Narrow of Paterson, NJ and Turning Point of Paterson, NJ. With a higher overall score, and a stronger proposal for services, the committee is recommending the proposal from <u>Straight and Narrow</u> who scored 80 out of 100 for a total of \$152,705 for 2019 to fulfill this addiction service need for the county.

Short Term Residential: There were two proposals received for this project. The agencies that applied for this project were: Straight and Narrow of Paterson, NJ and Turning Point of Paterson, NJ. With a higher overall score, and a stronger proposal for services, the committee is recommending the proposal from <u>Straight and Narrow</u> who scored 81 out of 100 for a total of \$183,210 for 2019 to fulfill this addiction service need for the county.

Outpatient Services for Upper County: New Bridge of Haskell, NJ was the only applicant for this project. The committee reviewed this proposal and is recommending this proposal for a total of \$34,415 for 2019 to fulfill this addiction service need for the county.

Alcohol, Tobacco and Other Drug (ATOD) for Families for Upper County: <u>Center for Family Resources</u> of Ringwood, NJ was the only applicant for this project. The committee reviewed this proposal and is recommending this proposal for a total of \$21,235 for 2019 to fulfill this addiction service need for the county.

Alcohol, Tobacco and Other Drug (ATOD) for Families for Lower County: Straight and Narrow of Paterson, NJ was the only applicant for this project. The committee reviewed this proposal and is recommending this proposal for a total of \$21,235 for 2019 to fulfill this addiction service need for the county.
