Ms. Browne provided the Mental Health and Addiction Services Director Report.

County Division of Mental Health & Addiction Staff Report October 2, 2019 Mental Health and Addictions Updates

- All municipalities in the county are stigma-free with the exception of Wanaque and Totowa.
   Wanaque is moving close to passing the resolution to be designated.
- PC Division of MH&AS is partnering with the PC Prosecutor's Office and local addictions agency to plan for 2019-2020 Operation Helping Hand (grant pending).
- NJDMHAS held its annual Suicide Awareness Conference recently. Some of the takeaways: 45% of those who die by suicide see a PCP within 30 days before suicide. For older adults, the number is more like 78%. Goal is to provide education to primary care docs to do suicide assessments.
- NJ County Mental Health Administrators working on a joint statement in response to mass violence and the stigmatization of those with mental illness.
- The Passaic County Recovery Walk was Saturday, Sept. 7<sup>th</sup> and was a great success.
- United in Prevention in Passaic County held a workshop on the Intersection of LGBTQ, Stigma, Mental Health & Substance Abuse on Sept. 27<sup>th</sup> and it was a great success.
- Planning for the October 2019 Teen Summit is in process.
- Passaic County Jail Medication Assisted Treatment Grant in the process.
- Department of Health, EMS Data and Intelligence reports 60-70% of overdoses are fentanyllaced.

County Alliance Steering Subcommittee (hereafter "CASS") Report

Ms. Huber presented the CASS approved Alliance Funding Formula for the FY2021-2025 Grant Cycle). Ms. Huber requested approval from the LACADA Committee. When LACADA approves the funding formula, the Letters of Intent (LOI) will be sent to the Municipal Alliances for the FY21 Grant Year.

Ms. Huber anticipates LACADA will be presented with the CASS approved Passaic County Strategic Plan at the February 5, 2020 meeting.

Ms. Huber reported that the Teen Summit will be held on October as held on October 18, 2019 at William Paterson University.

A meeting for the By Laws Review Committee will be schedule in the near future.

Ms. Browne presented a proposal from Prospect Park for a CY19 \$1,000.00 Stigma Free Grant for discussion and approval.

A motion was made by Ms. Doering and seconded by Ms. Shell to approve the Prospect Park mini grant for Stigma Free activities. Motion passed unanimously.

Ms. Browne presented a proposal from Jewish Family & Children's Services of Northern NJ (JFCSNNJ) in the amount \$17,500.00, to provide the CRAFT program for Families.

## **Program Analyst Monthly Notes August 2019**

- Effective July 1, 2019 Joint Commission Accreditation of Healthcare Organizations (JCAHO) requires that all patients in psychiatric hospitals and patients being evaluated or treated for behavioral health conditions as their primary reason for care in general hospitals be screened by Evidenced Based Suicide Risk Assessment Tools to assess suicide risk i.e. Columbia Suicide Risk Assessment Tool. A survey was conducted of the STCF's and diversion bed hospitals to learn what tool they are using. The results show that all are using a standardized tool, and most are using the Columbia Suicide Risk Assessment Tool. A recommendation was made that the results of the screening and assessment be included with the referral information provided to Centralized Admissions.
- We have hired a Contracts Unit Bureau Chief. Her name is Valerie Bosley and she will be joining us from DCF where she has had significant cost-based contract experience with supervisory responsibilities.

## **Columbia Suicide Severity Rating Scale**

It's been determined that any staff person, regardless of educational degree, can complete a suicide risk screening provided that they have completed their agency training on the provision of the screening. This is consistent with the intention of the Columbia Suicide Severity Rating Scale. What is critical is that the agency have a policy, on which staff have been trained, operationalizing how staff will follow up with ensuring immediate linkage to a clinician (MA level or higher) if the screening is positive. Licensing is going to ask to see the policies, and review them for adequacy.

## Murphy Signs Law to Require Mental Health Education in Schools

Mental health education will be integrated into health and physical education classes for all K-12 students in New Jersey under legislation signed into law Friday by Governor Phil Murphy. The law will take effect immediately and first apply to the 2020-2021 school year. It passed Assembly in June by a vote of 74-0, and the Senate in March 34-0.
