The meeting was called to order by Vice-Chairperson, Julie Rikon at 6:10 PM.

Also present was Francine Vince, Director of the Passaic County Human Services Department, Cynthia Gatica, Hudson and Passaic County Program Analyst for the New Jersey Division of Mental Health and Addiction Services, and Donna Huber, Passaic County Municipal Alliance Coordinator.

Ms. Vince made the announcement of the Open Public Meetings Act.

Members and others present introduced themselves.

A motion was made by Ms. Tedesco and seconded by Mr. Pagan to open the public portion of the meeting.

Motion passed unanimously.

Tina Miles, Director of Behavioral Health at St. Joseph's Regional Medical Center spoke during the public portion. Ms. Miles spoke about St. Joseph's Regional Medical Center's Psychiatric Emergency Services and answered board members questions.

#### **Old Business**

Passaic County Mental Health Grant RFP's were discussed. Ms. Vince informed the Committee that the Mental Health Board Proposal Review Committee met on February 15, 2019 to review all the submitted proposals for projects and made recommendations for funding in CY2019. (See Attachment 4). Ms. Vince further informed the Board there were options in regard to the RFP's. The Board could accept the Review Committees recommendations, review all the proposals then make recommendations, or request all submitting agencies come before the Board to provide information about their programs before recommendations were approved. Following discussion, the Board agreed to accept the Proposal Review Committees recommendations for funding. The Board would also like to have the funded agencies come before the Board at the May and June meetings to provide a presentation of their agencies services.

Ms. Tedesco made a motion to approve the Proposal Review Committees recommendations for funding. The motion was seconded by Mr. Nolan.

Motion passed unanimously.

New business

The State put out a Request for Proposal for Integrated Case Management Services in Passaic County. The Mental Health Board will have to review the submitted proposals and make recommendations to the state regarding the funding. However, a special meeting will have to be scheduled to afford the Board enough time to review the proposals and provide the State their recommendations. After discussion, a May 15, 2019 date was designated for the special meeting.

No correspondence was received.

A motion was made by Mr. Nolan and seconded by Ms. Armenta to adjourn the meeting.

Motion passed unanimously.

- County Division of MH and Addiction Services is planning a youth conference around anti-bullying, suicide prevention and anti-stigma.
- o Mental Health First Aid (MHFA) & Question, Persuade and Refer (QPR) Trainings are available. To schedule, please call 609-438-4235 (see flyer).
- ° There is a new DMHAS Director of Deaf and Hard of Hearing. Discussion about the need to learn more about the deaf and hard of hearing services in each county. MH Administrator to invite our counterparts to the Professional Advisory Committee mtg. DMHAS and Medicaid will look into whether interpreter services are reimbursable through Medicaid and FFS.
- Media awareness campaign about opiate use disorder will be kicking off soon. The campaign will be promoting Medication-Assisted Treatment (MAT).
- State and federal funds will be allocated to every jail across the state for case mgmt. and MAT. Each jail has different infrastructure. Val will be relying on Addictions Administrators to move this initiative forward. Funds will be distributed proportionate to size and population of the jail. RLI to come out in the next few months.
- ° DMHAS was awarded an additional \$11 million toward the opioid response.
- Ouestion arose about Narcan provided to inmates upon release from jail.
- ° 11,000 inmates in the jail statewide. 90% may be in jail between 24-48 hrs.
- New IDRC curriculum includes MAT and has been well received. The Intoxicated Drivers Program (IDP) will be doing new curriculum reviews at agencies. Spanish curriculum coming out shortly and being finalized. Affiliation Agreements for next year coming soon.
- ° There is a backlog in the DOH Office of Licensing due to staffing issues.
- Medicaid is all set for July 1 for the roll out for reimbursable peer specialists. There will be a group rate and individual rate. As long as the services are billed through a reimbursable clinic, they are reimbursable (this includes peers that work in the field). Supervision for peers must be a licensed clinical staff.
- ° Case mgmt. may not roll out on July 1. There will be regulations but not before July 1, 2019.
- Office Based Addiction Treatment (OBAT)—Discussed some of the barriers in primary care medicine as it relates to addiction treatment. There will be Navigators who will serve to link the person with resources in the community. Information about the Rutgers trainings for prescribers was sent out to providers.
- Individuals will be able to see the MAT provider as often as needed. Prescribers can be reimbursed at the Medicare rate which is more.

# The Revised 2019 Rental subsidy Policy and Consumer Agreement:

Please note, the following changes:

- Page 9 of the 2019 Rental Subsidy Policy, the Termination of Rental Subsidy has added "Suspension of DMHAS Rental Subsidy", for those who fail to correct or cure the violation (s) in the Warning Letter. The notice of Suspension of DMHAS Rental Subsidy shall inform the consumer that if the violation(s) are not cured within fourteen (14) days of the date of the Suspension notice, then the DMHAS subsidy will be suspended.
- Page 10 of the 2019 Rental Subsidy Policy, "Furnishings and Limited Ancillary Expenses".
  - o Consumers may qualify for limited one-time funds...
  - o To qualify, the consumer cannot have Net Family Assets in excess of \$2000

Brenda Browne facilitated the meeting but did not score the proposals.

The County received proposals for projects under this offering. All agencies submitted impressive applications for consideration. The Proposal Review Committee provided a thorough, comprehensive review of all submitted proposals and recommend the following:

Outpatient Mental Health for Lower Passaic County Grant #1: There were four proposals received for this project. The agencies that applied for this project were: SERV of Clifton, NJ; Mental Health Clinic of Passaic of Clifton/Passaic, NJ; Mental Health Association of Passaic County of Clifton NJ; and Jewish Family Services of Clifton/Passaic, NJ. With a higher overall score, and a stronger proposal for services, the committee is recommending the proposal from Mental Health Clinic of Passaic who scored 79.5 out of 100 for a total of \$70,000 for 2019 to fulfill this mental health service need for the county.

Outpatient Mental Health for Lower Passaic County Grant #2: There were four proposals received for this project. The agencies that applied for this project were: SERV of Clifton, NJ; Mental Health Clinic of Passaic of Clifton/Passaic, NJ; Mental Health Association of Passaic County of Clifton NJ; and Jewish Family Services of Clifton/Passaic, NJ. The committee is recommending the proposal from <a href="SERV">SERV</a> who scored 71.5 out of 100 for a total of <a href="\$\$\$\$\$570,000</a> for 2019 to fulfill this mental health service need for the county.

**Outpatient Mental Health for Up-County:** New Bridge of Haskell, NJ was the only applicant for this project. The committee reviewed this proposal and is recommending this proposal for a total of \$75,000 for 2019 to fulfill this mental health service need for the county.

**Peer Support Program:** There were two proposals received for this project. The agencies that applied for this project were: SERV of Clifton, NJ and Collaborative Support Program of Wayne, NJ. The committee is recommending the proposal from <u>Collaborative Support Program</u> who scored 90 out of 100 for a total of \$40,000 for 2019 to fulfill this mental health service need for the county.

**Psychiatric Emergency Services:** St. Joseph's Hospital of Paterson, NJ was the only applicant for this project. The committee reviewed this proposal and is recommending this proposal for a total of \$69,500 for 2019 to fulfill this mental health service need for the county.

**Partial Care 6-12**: Mental Health Clinic of Passaic of Passaic, NJ was the only applicant for this project. The committee reviewed this proposal and is recommending this proposal for a total of \$100,000 for 2019 to fulfill this mental health service need for the county.

**Supportive Housing Case Management Grant # 1:** There were three proposals received for this project. The agencies that applied for this project were: SERV of Clifton, NJ and Collaborative Support Program of Wayne, NJ and NJCDC of Paterson, NJ. The committee is recommending the proposal from <u>Collaborative Support Program</u> who scored 80.5 out of 100 for a total of \$75,000 for 2019 to fulfill this mental health service need for the county.

**Supportive Housing Case Management Grant # 2:** There were three proposals received for this project. The agencies that applied for this project were: SERV of Clifton, NJ and Collaborative Support Program of Wayne, NJ and NJCDC of Paterson, NJ. The committee is recommending the proposal from SERV who scored 67.5 out of 100 for a total of \$75,000 for 2019 to fulfill this mental health service need for the county.
