Update, October 23, 2024

Our Social Workers, Therapeutic Recreation staff and Unit Clerks distribute the Update to residents who wish to receive it.

On October 24, 2024, the transfer switch for the emergency generator for resident units 1-300, Pathway and 2-300 will be replaced with a new switch. Work will begin at 6 am. There will be two periods of time for one hour or less when there will not be any power in these areas at the beginning and end of the project. First shutdown is anticipated to begin at 7 am. Second shutdown will be at the end of the project which will be in the evening. During the shutdown periods, the following systems will be effected: fire alarm system, elevators to second floor (to Pathway and to 2-300), nurse call, lighting, HVAC, resident televisions, computer/phone systems. Residents on the second floor (Pathway and 2-300) will be temporarily transferred to resident units 2-400 and 1-300 of our Home because there would not be elevators to use for an emergency response to Pathway and 2-300 during the shutdown periods. During the shutdown periods, a fire watch will be conducted, battery-powered lighting will be provided, and arrangements have been made for medical equipment that is electrically powered. The anticipated weather on October 24, 2024 is conducive to brief interruptions of HVAC service. Nursing Supervisors will inform residents/designated representatives of the temporary resident transfers.

Residents who vote by absentee ballot should have received their ballots. As a reminder, the ballots must be postmarked by Election Day. Residents may direct any concerns to their Social Workers.

On October 22, 2024, a resident who lives on resident unit 2-400 tested positive for COVID. Symptoms of residents and staff are being monitored. Residents and staff who had close contact will be tested.

Patrick Kuiken, RN, BSN, LTC-CIP, Infection Preventionist is continuing to administer the 2024-2025 Moderna Spikevax COVID-19 vaccine and/or the Influenza vaccine to residents if the resident and/or their designated representatives have provided consent. Mr. Kuiken may be reached at 973-585-2181 to answer any questions.

In accordance with New Jersey P.L. 2019 Chapter 330, C:26:2H-18.79, all staff who do not have a medical or religious exemption must be vaccinated for influenza each year. References in the law to staff include but are not limited to employed and contract staff, volunteers, and physicians. Flyers are posted throughout our Home indicating the dates/times when the influenza vaccines are available. Patrick Kuiken, RN, BSN, LTC-CIP, Infection Preventionist is available to answer any questions.
